FDOT to Host a Public Meeting for two Roadway Projects

Along SW 336 Street/Davis Parkway and State Road (SR) 9336/Palm Drive/SW 344 Street from SR 997/Krome Avenue to SR 5/US 1

Miami, FL – The Florida Department of Transportation (FDOT) District Six will host a public meeting for two roadway projects along SW 336 Street/Davis Parkway and SR 9336/Palm Drive/SW 344 Street from SR 997/Krome Avenue to SR 5/US 1, in Miami-Dade County. The estimated combined construction cost of these projects is \$3.1 million. The construction schedule for each project is listed below:

- SW 336 Street/Davis Parkway from SR 997/Krome Avenue to SR 5/US 1: Work is expected to begin in September 2019 and last about 20 months.
- SR 9336/Palm Drive/SW 344 Street from SR 997/Krome Avenue to SR 5/US 1: Work is expected to begin in August 2019 and last about three months.

The public meeting will be held from 6 p.m. to 8 p.m. on Wednesday, February 15, 2017, at the William F. Dickinson Community Center, 1601 N. Krome Avenue, Homestead, FL 33030. The meeting will be an open house, from 6 p.m. to 8 p.m. Graphic displays will be shown during the hearing, and FDOT representatives will be available to discuss the project.

The proposed work for these projects include:

SW 336 Street/Davis Parkway from SR 997/Krome Avenue to SR 5/US 1:

- Reconstructing Davis Parkway to extend the capacity of existing pavement to facilitate truck bypass
- Adding right turn lanes at the intersections of Davis Parkway and Krome Avenue, and Davis Parkway and US 1
- Improving drainage throughout the project limits
- Adding sidewalk on Davis Parkway
- Repaving and restriping the roadway
- Installing curb ramps
- Upgrading lighting, signalization, signing and pavement markings, crosswalks

SR 9336/Palm Drive/SW 344 Street from SR 997/Krome Avenue to SR 5/US 1:

- Adding right turn lanes southbound to westbound on Krome Avenue and US 1
- Repaving and restriping the roadway
- Upgrading lighting, signalization, signing and pavement markings
- Improving drainage along Krome Avenue
