FDOT to Host a Public Hearing for a Roadway Project

*State Road (SR) 932/NW 103 Street/West 49 Street
from SR 826/Palmetto Expressway Interchange to East 5 Avenue*

Miami, FL – The Florida Department of Transportation District Six (FDOT) will host a public hearing for two roadway improvement projects along SR 932/NW 103 Street/West 49 Street from SR 826/Palmetto Expressway Interchange to East 5 Avenue, in Miami-Dade County. Construction is expected to begin in September 2017 and last for about nine months. The estimated construction cost of the project is \$2 million.

The public hearing will be held from 6 p.m. to 8 p.m. on Tuesday, November 1, 2016 at Miami-Dade College, Hialeah Campus Room 5101-B, 1780 West 49 Street, Hialeah, FL 33012. The entrance is located on West 17 Court. Parking lot five is reserved for all attendees. The hearing will begin as an open house, from 6 p.m. to 8 p.m., with a formal presentation starting at 6:30 p.m. Graphic displays will be shown during the hearing, and FDOT representatives will be available to discuss the project.

The proposed work for this project includes:

- Repaving affected medians
- Modifying existing medians
- Widening W 16 Street to add additional east and westbound turn lanes at the intersection of NW 103 Street

- Modifying existing driveway access
- Installing high emphasis crosswalks
- Replacing and repairing street lights
- Improving traffic signals
- Upgrading pedestrian and roadway signs
