Closures on I-95, Adjacent Ramps and North Miami Avenue

MIAMI, Fla. – The following closures on I-95, adjacent ramps and North Miami Avenue will be scheduled as noted below:

I-95 Lane Closures

- Friday, January 15 - Up to two lanes on southbound I-95 from NW 11 Street to NW 8 Street will be closed between the hours of 11 p.m. and 11 a.m.

Diversion of Northbound I-95 Traffic to Exit 4A

- Friday, January 15 and Monday, January 18 - All three travel lanes on northbound I-95 will be closed just north of SR 836 between the hours of 11:45 p.m. and 11 a.m. on Friday. One lane will be opened at 7 a.m. The closure on Monday will occur between the hours of 10 p.m. and 6 a.m. Drivers traveling on northbound I-95 will be diverted to the eastbound I-195 ramp (Exit 4A) just after SR 836 to reconnect with northbound I-95 at approximately NW 23 Street.

Northbound I-95 Ramp to Westbound SR 836 Detour

- Tuesday, January 19 and Wednesday, January 20 - The northbound I-95 ramp to westbound SR 836 will be closed between the hours of 10 p.m. and 5:30 a.m. Drivers can:
 - Enter the eastbound I-395 ramp
 - Exit at NE 2 Avenue/Biscayne Boulevard (Exit 2B), then turn right on NE 2 Avenue
 - Turn right on NE 11 Street
 - Turn right on NE 1 Avenue to access westbound I-395 to continue onto westbound SR 836

Westbound I-395 Ramp to Southbound I-95 Detour

- Friday, January 15 and Monday, January 18 - The westbound I-395 ramp to southbound I-95 will be closed between the hours of 11 p.m. and 7 a.m. on Friday and 9 p.m. and 5:30 a.m. on Monday. Drivers can:
 - Go north on I-95, then exit at NW 62 Street
 - Turn left at NW 62 Street to access the southbound I-95 ramp

Eastbound SR 836 Ramp to Southbound I-95 Detour

- Friday, January 15 and Monday, January 18 - The eastbound SR 836 ramp to southbound I-95 will be closed between the hours of 11 p.m. and 11 a.m. on Friday, and 9 p.m. and 5:30 a.m. on Monday. Drivers can:

- Access the ramp to I-95 South/NW 8 Street
- Exit at NW 8 Street and continue south on NW 3 Court to access the I-95 south ramp after NW 2 Street

Closure of the Southbound I-95 Ramp to Eastbound I-395 and all Southbound I-95 Lanes at SR 836

- Tuesday Early Morning, January 19 - The southbound I-95 ramp to eastbound I-395 and all southbound I-95 lanes will be closed at SR 836 between the hours of 12:30 a.m. and 4 a.m. to allow the contractor to move a crane across the roadway. Drivers can use the detour routes below.
 - Non-Tolled detour route for southbound I-95:
 - Exit at the SR 836 West Ramp, then exit at NW 14 Street
 - Turn left at NW 12 Avenue, then turn left at NW 11 Street
 - Turn right at NW 8 Street Road, then turn left at NW 8 Street
 - Turn right at NW 3 Court to access the I-95 south ramp after NW 2 Street
 - Non-Tolled detour route for eastbound I-395:
 - Exit at the SR 836 West Ramp, then exit at NW 14 Street
 - Turn left at NW 12 Avenue, then turn left at NW 11 Street
 - Turn right at NW 8 Street Road, then turn left at NW 8 Street
 - Continue east on NW 8 Street, then turn left at Biscayne Boulevard to access the A1A North/Miami Beach ramp
 - Tolloed detour route for southbound I-95:
 - Exit at the SR 836 West Ramp, then exit at NW 12 Avenue
 - Turn left at NW 12 Avenue to access the SR 836 east entrance ramp
 - Continue east on SR 836 to access the I-95 south ramp
 - Tolloed detour route for eastbound I-395:
 - Exit at the SR 836 West Ramp, then exit at NW 12 Avenue
 - Turn left at NW 12 Avenue to access the SR 836 east entrance ramp
 - Continue east on SR 836 to access eastbound I-395

North Miami Avenue Closure for Installation of Bridge Segments Over the Roadway

- Friday, January 15 and Monday, January 18 through Friday, January 22 - Two right lanes on North Miami Avenue will be closed from NW 14 Street to I-395 between the hours of 8 p.m. to 10 p.m. At 10 p.m., two right lanes from NW 14 Street to NW 13 Street will remain closed and all lanes on North Miami Avenue will be closed from NW 13 Street to south of I-395 until 5:30 a.m. In addition, two lanes will be closed from NW 13 Street to I-395 between the hours of 6 a.m. and 8 a.m. to allow the contractor to perform surveying operations. Drivers can:
 - Go east on NE 14 Street, then turn right on NE 2 Avenue
 - Turn right on NE 11 Street to connect with North Miami Avenue

Please note that this schedule may change due to bad weather or other unforeseen conditions.

The work is part of the I-395/SR 836/I-95 Design-Build Project that will reconstruct the I-395 corridor from the SR 836/I-395/I-95 (Midtown) Interchange to the MacArthur Causeway Bridge, including the construction of a Signature Bridge over NE 2 Avenue

and Biscayne Boulevard; double-deck SR 836 from west of NW 17 Avenue to the Midtown Interchange and the replacement of the concrete pavement on I-95 from NW 8 Street to NW 29 Street.
