### **Closures on I-95, I-395, SR 836 and Adjacent Ramps**

**MIAMI, Fla.** – The following closures on I-95, I-395, SR 836, adjacent ramps and local roads will be scheduled as noted below:

#### **Full Closure of Southbound I-95 at SR 836/I-395**

- Thursday, March 25 - southbound I-95 lanes will be closed at SR 836 between the hours of 11:45 p.m. and 5:30 a.m. The closures will allow the contractor to erect steel bridge beams over the roadway for the widening of the eastbound SR 836 ramp to northbound I-95. The southbound I-95 ramps to eastbound I-395 and westbound SR 836 will be open during this time frame. Drivers can use the detour routes below:
  - Non-Tolled detour route for southbound I-95:
    - Exit at the SR 836 West ramp, then exit at NW 14 Street
    - Turn left at NW 12 Avenue, then turn left at NW 11 Street
    - Turn right at NW 8 Street Road, then turn left at NW 8 Street
    - Turn right at NW 3 Court to access the I-95 south ramp after NW 2 Street
  - Tolloed detour route for southbound I-95:
    - Exit at the SR 836 West Ramp, then exit at NW 12 Avenue
    - Turn left at NW 12 Avenue to access the SR 836 east entrance ramp
    - Continue east on SR 836 to access the I-95 south ramp

#### **I-95 Closures**

- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - Up to four lanes on southbound I-95 from NW 29 Street to NW 8 Street will be closed between the hours of 9 p.m. and 5:30 a.m.
- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - Up to four lanes on northbound I-95 will be closed nightly from NW 8 Street to NW 29 Street between the hours of 9 p.m. and 5:30 a.m.

#### **Southbound I-95 Ramp to Westbound SR 836 Detour**

- Sunday, March 28 - The southbound I-95 ramp to westbound SR 836 will be closed between the hours of 9 p.m. and 5:30 a.m. Drivers can:
  - Continue south on I-95
  - Exit at SW 7 Street/Brickell Avenue (Exit 1B), then turn left at SW 8 Street

- Enter the northbound I-95 ramp, then access the ramp to westbound SR 836

### **NW 17 Street Daytime Closures Under I-95**

- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - One lane on westbound NW 17 Street under I-95 will be closed as needed between the hours of 7 a.m. and 6 p.m. to allow the contractor to work on bridge foundations. Traffic will be flagged around the work zone.

### **I-395 Mainline Lane Closures**

- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - One lane on mainline eastbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.
- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - One lane on mainline westbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.

### **Westbound I-395 Ramp to Northbound I-95 Detour**

- Thursday, March 25 and Sunday, March 28 - The westbound I-395 ramp to northbound I-95 will be closed between the hours of 10 p.m. and 5:30 a.m. Drivers can:
  - Access the southbound I-95 ramp
  - Exit at SW 7 Street/Brickell Avenue (Exit 1B), then turn left at SW 8 Street
  - Enter the northbound I-95 ramp, then continue north on I-95

### **Daytime Lane Closure on Biscayne Boulevard**

- Monday, March 29 through Thursday, April 1 - One northbound lane on Biscayne Boulevard from NE 11 Terrace to NW 13 Street will be closed between the hours of 9 a.m. and 3:30 p.m. for drainage work.

### **North Bayshore Drive Ramp to Eastbound MacArthur Causeway**

- Thursday, March 25 - The North Bayshore Drive ramp lane to eastbound MacArthur Causeway will be closed between the hours of 10 p.m. and 5:30 a.m. Drivers can:
  - Turn right on NE 13 Street, then turn left on Biscayne Boulevard
  - Turn right on NE 11 Street, then turn left on NE 2 Avenue
  - Turn left on NE 10 Street, then turn left on Biscayne Boulevard to access the ramp to MacArthur Causeway

### **Closure of Eastbound NW 14 Terrace**

- Starting on Thursday, March 25, the eastbound lane on NW 14 Terrace will be closed from NW 3 Avenue to NW 2 Avenue until further notice to allow the contractor to construct bridge foundations. Drivers can use NW 15 Street as an alternate.

### **Nighttime Closure of the NW 3 Avenue/NW 14 Street Intersection for Bridge Segment Erection**

- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - The NW 3 Avenue/NW 14 Street intersection will be closed between the hours of 10 p.m. and 5:30 a.m. to allow the contractor to place bridge segments over the roadway.

- Northbound drivers on NW 3 Avenue can:
  - Turn right on NW 13 Street, then turn left on NW 1 Place
  - Turn right on NW 14 Street, then turn left on NW 1 Avenue
  - Turn left on NW 16 Street to connect with NW 3 Avenue
- Southbound drivers on NW 3 Avenue can:
  - Turn left on NW 16 Street, then turn right on NW 2 Avenue
  - Turn left on NW 15 Street, then turn right on NW 1 Avenue
  - Turn left on NW 14 Street, then turn right on North Miami Avenue
  - Turn right on NW 11 Street to connect with NW 3 Avenue
- Eastbound drivers on NW 14 Street can:
  - Turn left on NW 7 Avenue, then turn right on NW 17 Street
  - Turn right on NW 1 Avenue to connect with NW 14 Street
- Westbound drivers on NW 14 Street can:
  - Turn right on NW 1 Avenue, then turn left on NW 17 Street
  - Turn left on NW 7 Avenue to connect with NW 14 Street

### **Closure of NW 13 Street at NW 1 Court**

- A section of NW 13 Street at NW 1 Court will be closed for a period of approximately four more weeks. The closure will allow the contractor to construct bridge caps for the new I-395 bridges.

### **Long Term Closure of NW Miami Court and NW 13 Street**

- NW Miami Court and NW 13 Street will remain closed until, Sunday, June 6 to allow the contractor to safely install bridge segments. Access to business driveways will be maintained.

### **Long Term Closure of NW 1 Court**

- NW 1 Court from NW 13 Street to NW 14 Street and NW 13 Street from NW 1 Avenue to NW 1 Court will remain continuously closed until further notice to allow the contractor to work on bridges over the roadways.

### **SR 836 Lane Closures**

- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - Two lanes on eastbound SR 836 from NW 17 Avenue to I-95 will be closed as needed between the hours of 9 p.m. and 5:30 a.m.
- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - Two westbound lanes on SR 836 from I-95 to NW 17 Avenue will be closed as needed between the hours of 9 p.m. and 5:30 a.m.

### **Eastbound SR 836 Ramp to Northbound I-95 Detour**

- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - The eastbound SR 836 ramp to northbound I-95 will be closed between the hours of 9 p.m. and 5:30 a.m. Drivers can:
  - Access the southbound I-95/NW 8 Street ramp, then exit at the NW 8 Street/PortMiami ramp
  - Turn left at NW 8 Street
  - Turn left at NW 3 Avenue to access the northbound I-95 ramp

### **Northbound NW 12 Avenue Ramp to Eastbound SR 836 Detour**

- Sunday, March 28 through Thursday, April 1 - The northbound NW 12 Avenue ramp to eastbound SR 836 will be closed between the hours of 9 p.m. and 5:30 a.m. Drivers can:
  - Continue north on NW 12 Avenue, then turn left on NW 12 Street
  - Turn right on NW 13 Avenue, then turn right on NW 14 Street
  - Turn right on NW 12 Avenue to access the southbound NW 12 Avenue entrance ramp to SR 836 east

### **Full Closure of NW 17 Avenue**

- Thursday, March 25 and Sunday, March 28 through Thursday, April 1 - NW 17 Avenue will be closed between NW 7 Street and the north side of SR 836 between the hours of 9 p.m. and 7 a.m.
  - Drivers on northbound NW 17 Avenue heading west on SR 836 can:
    - Turn west on NW 7 Street
    - Turn right on NW 27 Avenue to access the SR 836 west entrance ramp
  - Drivers on northbound NW 17 Avenue continuing north can:
    - Turn west on NW 7 Street, then turn right on NW 22 Avenue
    - Turn right on NW 20 Street to connect with NW 17 Avenue
  - Drivers on southbound NW 17 Avenue continuing south can:
    - Turn west on NW 20 Street, then turn left on NW 22 Avenue
    - Turn left on NW 7 Street to connect with NW 17 Avenue

### **Daytime/Nighttime NW 7 Avenue Lane Closures**

- Thursday, March 25 through Thursday, April 1 - One southbound lane on NW 7 Avenue will remain continuously closed from NW 14 Street to NW 15 Street until 5 p.m. on Thursday, April 1.

Please note that this schedule may change due to bad weather or other unforeseen conditions.

The work is part of the I-395/SR 836/I-95 Design-Build Project that will reconstruct the I-395 corridor from the SR 836/I-395/I-95 (Midtown) Interchange to the MacArthur Causeway Bridge, including the construction of a Signature Bridge over NE 2 Avenue and Biscayne Boulevard; double-deck SR 836 from west of NW 17 Avenue to the Midtown Interchange and the replacement of the concrete pavement on I-95 from NW 8 Street to NW 29 Street.
