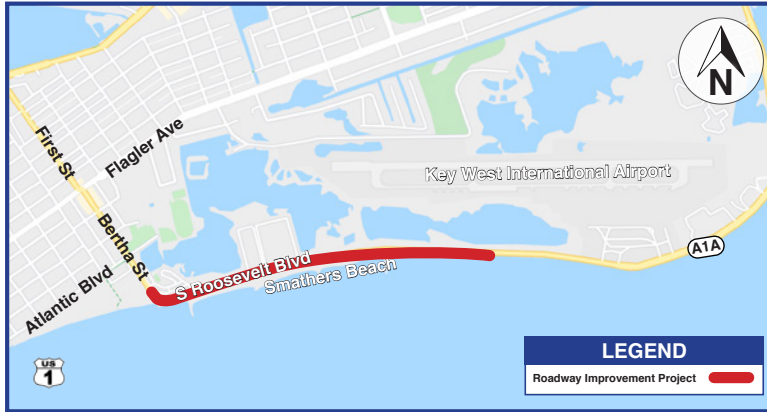

# PUBLIC MEETING NOTIFICATION

## FLORIDA DEPARTMENT OF TRANSPORTATION DISTRICT SIX

State Road (SR) A1A/South Roosevelt Boulevard  
From Bertha Street to Smathers Beach and from Go Lane to SR 5/US 1/  
North Roosevelt Boulevard  
Project Identification Numbers: 250548-8-52-01 and 446007-1-52-01

The Florida Department of Transportation (FDOT) is developing the design for two roadway improvement projects along SR A1A/ South Roosevelt Boulevard from Bertha Street to Smathers Beach and from Go Lane to SR 5/US 1/North Roosevelt Boulevard, located in Monroe County.

### PROJECT DETAILS

#### SR A1A/South Roosevelt Boulevard from Bertha Street to Smathers Beach

- Repaving and restriping the roadway
- Installing new signs and pavement markings
- Closing the retaining wall gaps at the beginning and end of the project limits
- Reconstructing the existing Promenade along the south side of SR A1A
- Adding sidewalk along the northside
- Providing three pedestrain crossings with High-Intensity Activated Crosswalk (HAWK) pedestrain signals
- Elevating the roadway in specific locations
- Upgrading the drianage system and adding a pump station to address stormwater runoff

#### SR A1A/South Roosevelt Boulevard from Go Lane to SR 5/US 1/North Roosevelt

- Repaving and restriping the roadway
- Upgrading curb ramps

### ESTIMATED PROJECT COST

\$11.9 million (Combined)

### PROJECT DATES

SR A1A/South Roosevelt Boulevard from Bertha Street to Smathers Beach: Work is expected to begin in October 2023 and last about 37 months.

SR A1A/South Roosevelt Boulevard from Go Lane to SR 5/US 1/ North Roosevelt: Work is expected to begin in December 2023 and last about five months

Please note that the construction duration is subject to change.

### POSSIBLE EFFECTS DURING CONSTRUCTION

Work will be done in phases to reduce the effects of construction on the community. Vehicular and pedestrain traffic will be impacted.

### MAINTENANCE OF TRAFFIC

During construction, temporary lane closures will occur during construction. Flaggers will be used to control traffic flow. Pedestrian access will be maintained within the existing roadway. Access to businesses and residences will maintained within the existing roadway.
