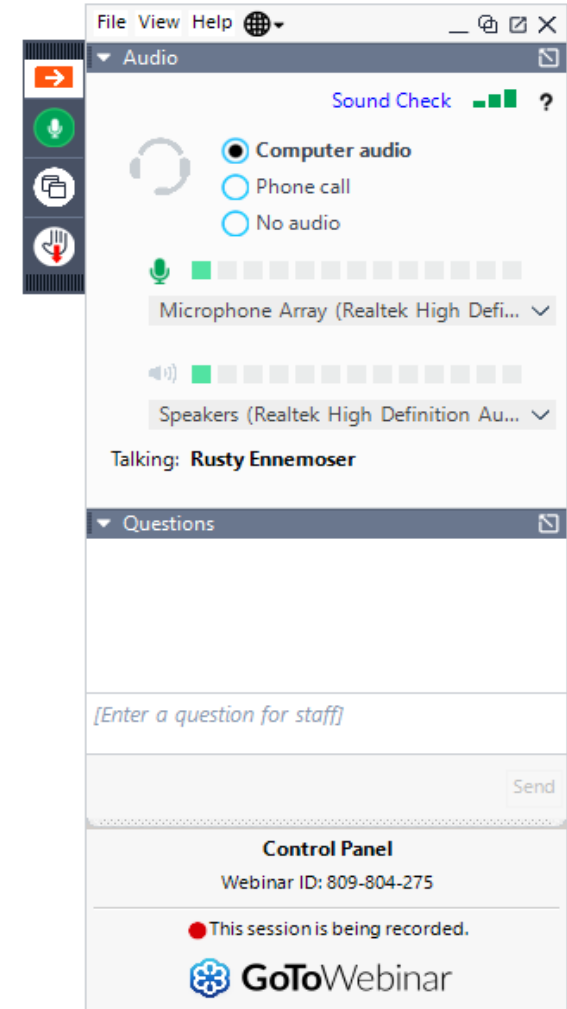

Rules of Engagement

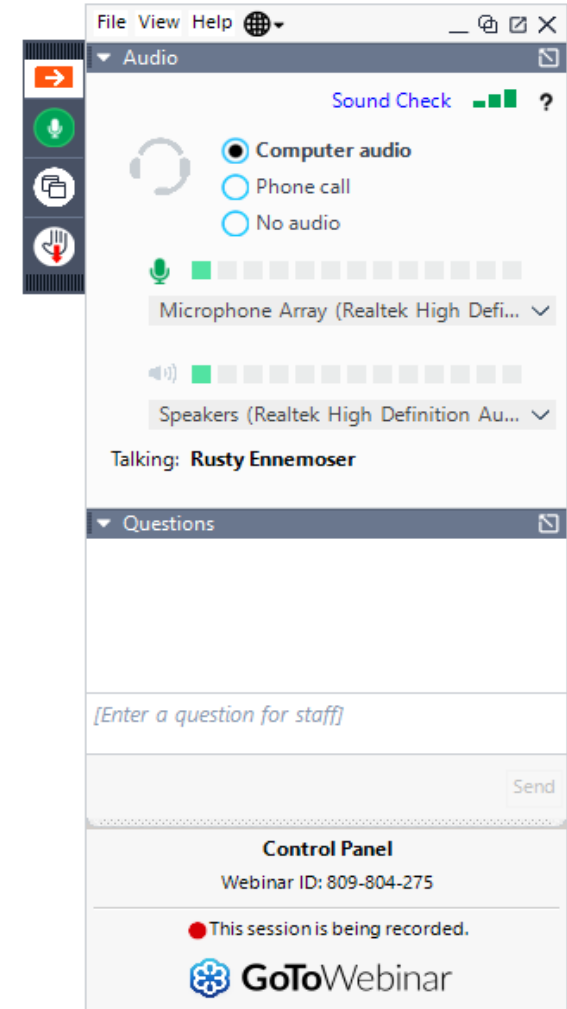

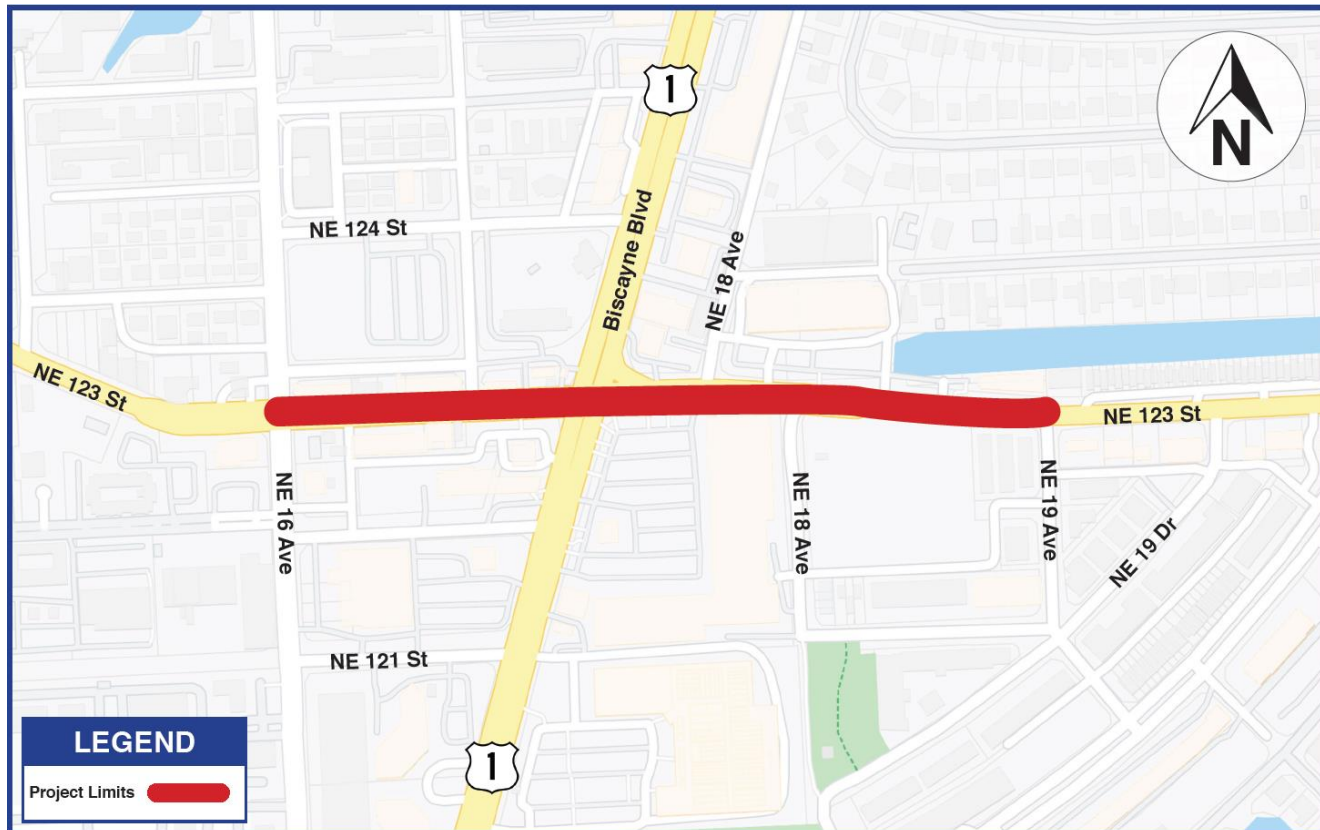

Purpose and Need:

- Preserve and extend the life of the existing pavement by repaving the road
- Enhance the safety and improve the operation of the corridor

The project is currently in 60% design phase.

- Work with municipalities to review plans
- Receive feedback from the public



Project Scope

- Eliminating the westbound left turn access to NE 18 Avenue
- Widening for additional westbound left-turn lane and modifying the traffic median
- Extending the westbound right-turn lane
- Upgrading the traffic signals
- Upgrading the curb ramps, pedestrian signals and crosswalk pavement markings
- Upgrading the traffic signage
- Repaving and restriping the road
- Adjusting the manholes



What to Expect During Construction

Maintenance of Traffic (MOT):

- Lane closures shall occur only during non-peak hours or on non-event days/weekends
- At least one travel lane will remain open at all times



Non-peak hours are:

- Lane Closures

9 a.m. to 3:30 p.m. Weekdays and Weekends

9 p.m. to 5:30 a.m. Sunday through Thursday

11 p.m. to 7 a.m. Friday and Saturday

What to Expect During Construction

Phasing:

- Phase 1:

- Construct curb ramps, replace sidewalk and drainage structures
- Install new signing and signalization

- Phase 2:

- Construct traffic separator and widen lanes





What to Expect During Construction

Phasing:

- Phase 3:



- Repave and restripe the road, adjust manholes and valves
- Install final marking



What to Expect During Construction



Posted Speed:

- Existing 35 Mile Per Hour (MPH) west of Biscayne Blvd and 30 Mile Per Hour (MPH) east of Biscayne Blvd limit will remain



Dust:

- The contractor will be required to water and sweep in order to minimize construction-related dust

What to Expect During Construction



Noise:

- Some noise should be expected during allowable construction time



Access:

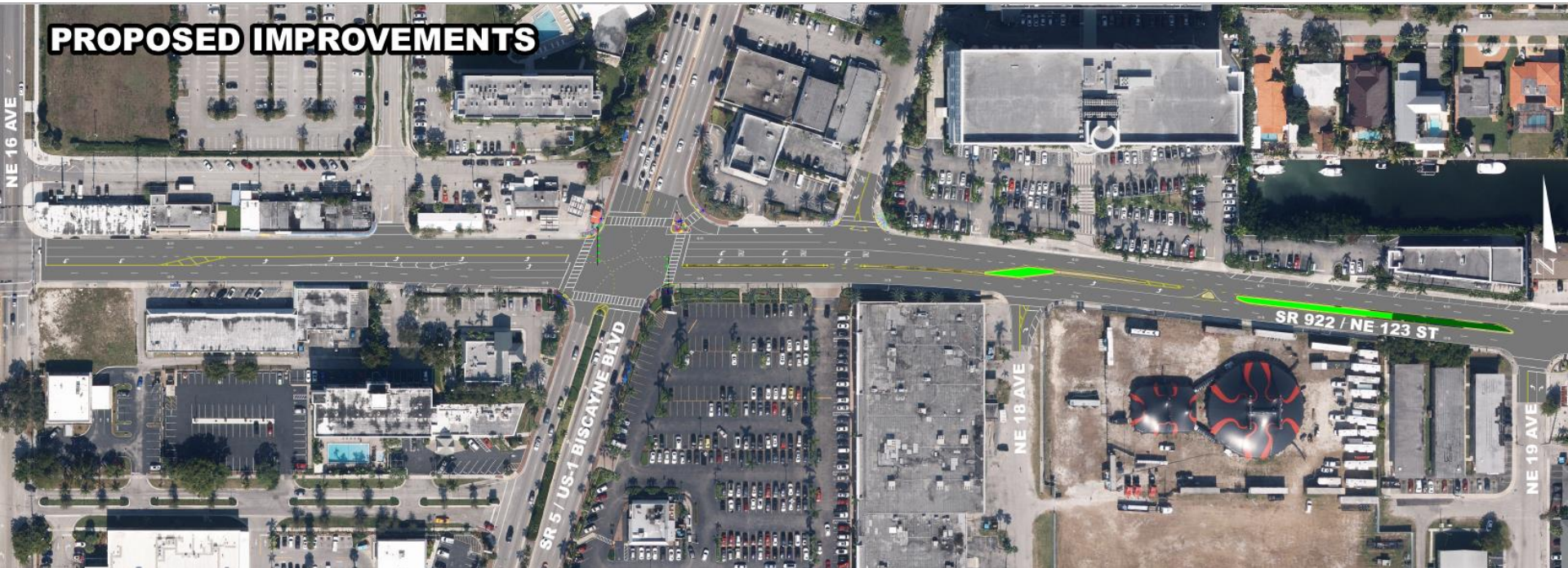
- Access to businesses and residences will be maintained
