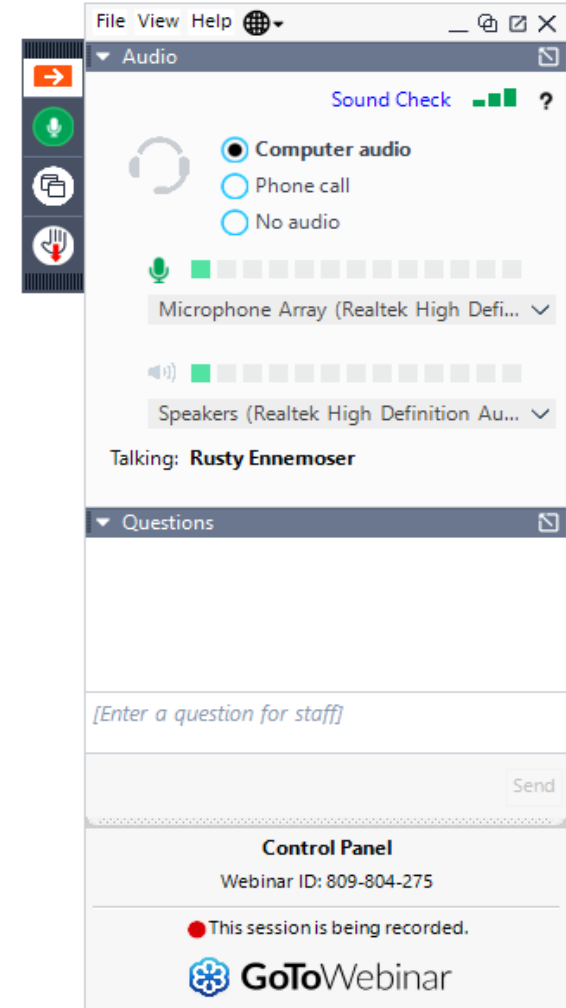

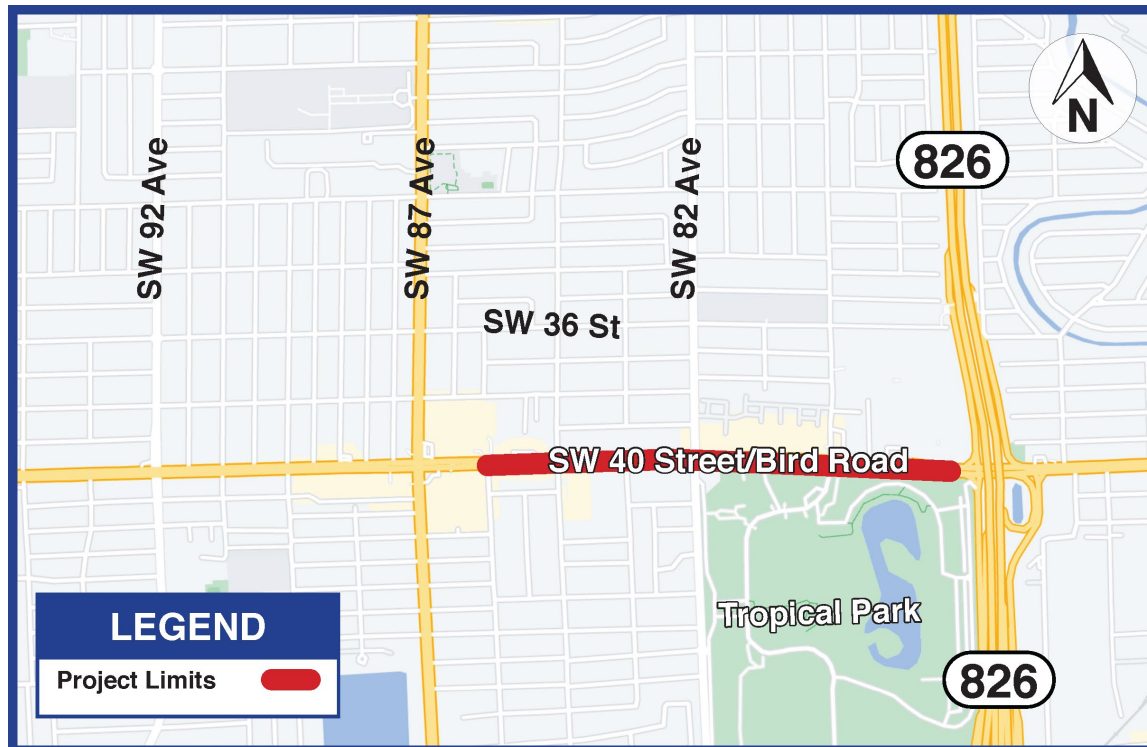

Project Information

Purpose and Need:

- Extending the service life of the pavement along SR 976/SW 40 Street/ Bird Road
- Enhancing safety by upgrading pedestrian signals along the road

Municipalities in the area:

- None (Unincorporated Miami-Dade County)

SR 976/SW 40 St/Bird Rd from E of SW 87 Ave to W of SR 826/Palmetto Expressway

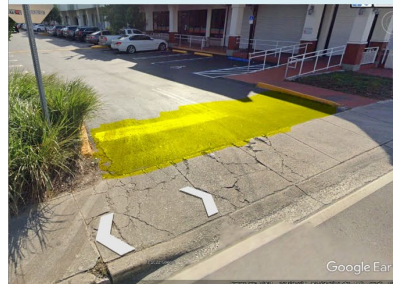

What to Expect During Construction

Maintenance of Traffic (MOT):

- Lane closures shall occur only during non-peak hours or non-event days/weekends
- No more than one travel lane at a time closed in each direction

Non-peak hours are:

- Lane Closures
11 p.m. to 6:30 a.m. nightly



Construction Phasing

Phasing:

- Phase 1:
 - “A” sidewalk, driveway reconstruction and pedestrian signals
 - “B” pedestrian signal upgrades in median
- Phase 2:
 - Repaving and restriping operations





What to Expect During Construction



Speed:

- Existing 40 miles per hour (mph) limit will remain



Dust:

- The contractor will be required to water and sweep in order to minimize construction-related dust

What to Expect During Construction



Noise:

- Some noise should be expected during allowable construction time



Access:

- Access to businesses and residences will be maintained
