



SR 934/NW 79 Street from NW 27 Avenue to NW 1 Place






Project Scope

- Installing midblock pedestrian crossings at several locations
- Modifying the medians at the following locations along NW 79 Street:
 - NW 15 Avenue
 - NW 14 Place
 - NW 9 Avenue
 - NW 8 Court
- Closing unpermitted driveways
- Upgrading pedestrian signage, signals and ramps
- Improving left turn lanes at the intersection of NW 79 Street and NW 17 Avenue
- Improving lighting at proposed pedestrian crossings




SR 934/NW 79 Street from NW 27 Avenue to NW 22 Avenue

What to Expect During Construction

Maintenance of Traffic (MOT):

- Lane closures shall occur only during non-peak hours or on non-event days/weekends
- At least one travel lane will remain open at all times

Non-peak hours are:

9 a.m. to 3:30 p.m. Weekdays and Weekends9 p.m. to 5:30 a.m. Sunday through Thursday11 p.m. to 7 a.m. Friday and Saturday



What to Expect During Construction Phasing:

- Construct median modifications
- Install traffic signs, signal and lighting improvements
- Construct mid-block crossing and pedestrian ramps
- Widen the road were necessary
- Repave and restripe the roadway





What to Expect During Construction



Posted Speed:

- Existing 40 mile per hour (MPH) speed limit along
 SR 934 from NW 27 Avenue to SR 9A/I-95 will
 remain
- Existing speed limit of 35 MPH speed limit along SR 934 from SR 9A/I-95 to NW 1 Place will remain



The contractor will be required to water and sweep in order to minimize construction-related dust



What to Expect During Construction

Noise:

• Some noise should be expected during allowable construction time



Access:

 Access to businesses and residences will be maintained
