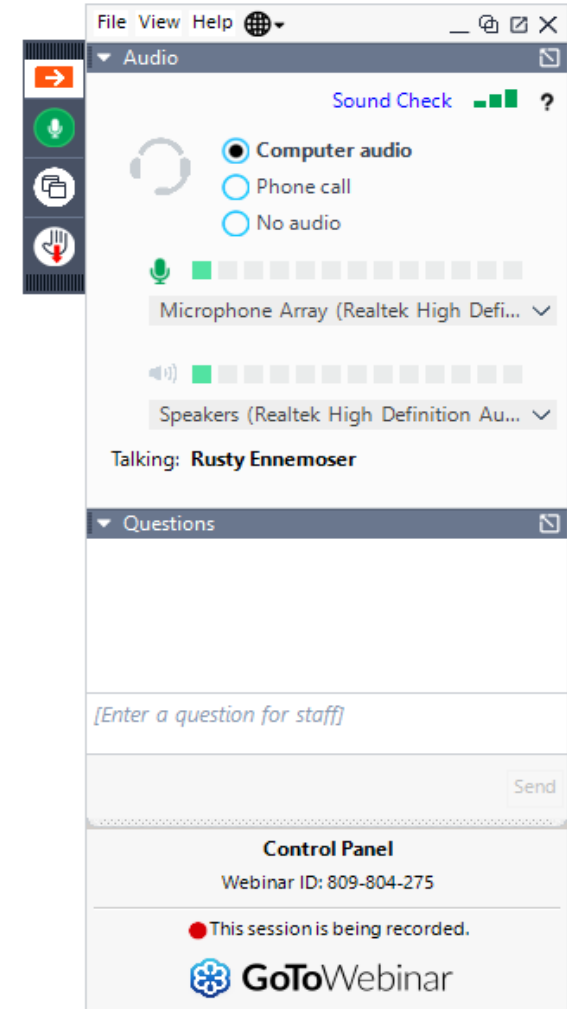

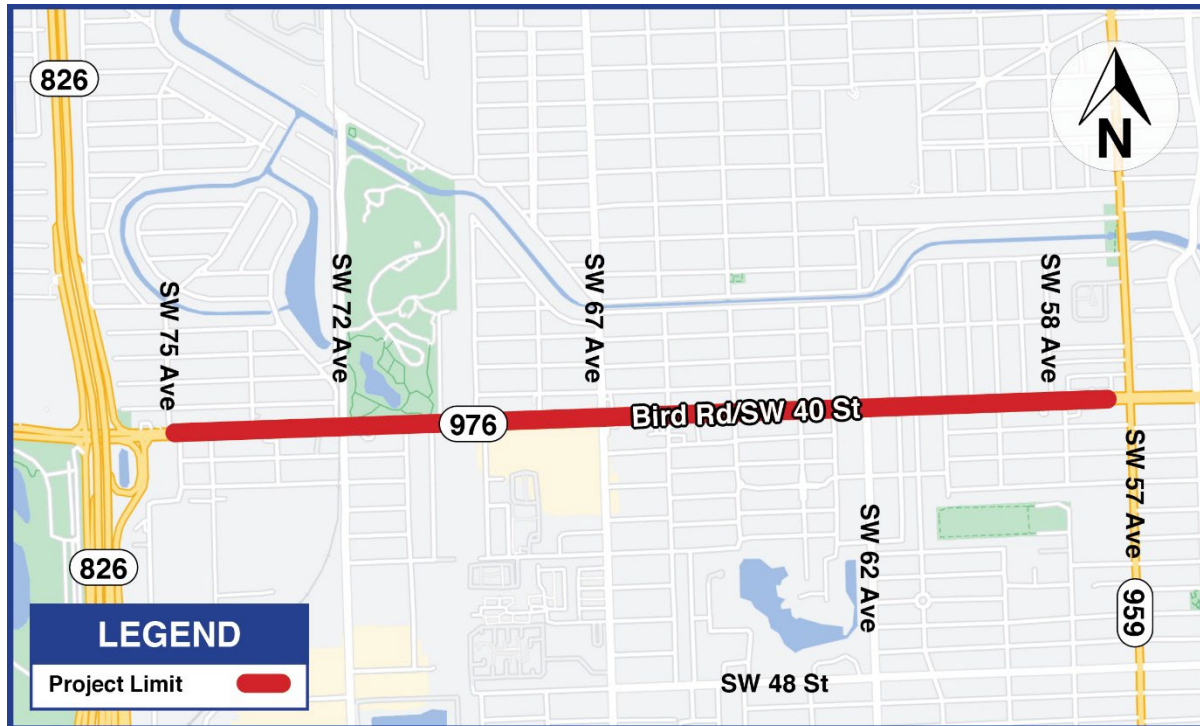

Project Information

Purpose and Need:

- Extending and preserving the service life of roadway pavement
- Enhancing the safety along the roadway by modifying full median openings
- Extending turn lanes
- Enhancing visibility of signals on the road
- Adding new signage and pavement markings

Municipality in the area:

- Unincorporated Miami-Dade County
- City of South Miami





Project Schedule and Cost

Construction Estimated Start Date	Summer 2024
Construction Estimated Duration	18 months
Construction Estimated End Date	Winter 2025
Total Construction Estimated Cost	\$4.2 million



The project is currently in 60% design phase.

Adjacent Project

The adjacent roadway resurfacing project to the west on SR 976/Bird Road/SW 40 Street from east of SW 87 Avenue to west of SR 826/Palmetto Expressway will be constructed in conjunction with this project.

The public information meeting was held on May 31, 2022



Project Scope

- Repaving and restriping existing roadway pavement
- Extending turn lanes at SW 72 Avenue, SW 67 Avenue and SW 62 Avenue
- Modifying median openings at SW 62 Court, SW 60 Court, SW 61 Avenue (to be closed) and SW 59 Avenue
- Adjusting manholes tops and valves in roadway pavement



Project Scope

- Repairing/replacing damaged sidewalks, driveways, and drainage inlets
- Upgrading signage and pavement markings to meet current standards and replacing/adding special emphasis markings for crosswalks at signalized intersections
- Upgrading all pedestrian signals, detectors, curb ramps and detectable warning surfaces
- Enhancing visibility of signals on the road at intersections

What to Expect During Construction



Maintenance of Traffic (MOT):

- Lane closures shall occur only during non-peak hours or on non-event days/weekends
- At least one travel lane in each direction will remain open at all times

Non-peak hours are:

- Single Lane Closures
9 a.m. to 3:30 p.m. weekdays and weekends
- Weekdays and Weekends – For Paving/Striping Only
One Lane Closure: 7 p.m. to 6 a.m.
Two Lane Closure: 10 p.m. to 6 a.m.

Construction Phasing



Phasing:

- Phase 1 (north and south side of road):
 - Install and maintain temporary inlet protection
 - Install temporary work signs, barricades, and other traffic control devices
 - Construct drainage curb and gutter, sidewalk pedestrian ramps, signing, signalization, and drainage

Construction Phasing



Phasing:

- Phase 2 (Median Work):
 - Install and maintain temporary inlet protection
 - Install temporary work signs, barricades, and other traffic control devices
 - Construct drainage curb and gutter, sidewalk pedestrian ramps, signing, signalization, and drainage

Construction Phasing



Phasing:

- Phase 3 (Paving and Striping):
 - Install and maintain temporary inlet protection
 - Install temporary work signs, barricades, and other traffic control devices
 - Place final pavement surface
 - Place final striping

What to Expect During Construction



Speed:

- Existing 40 Mile Per Hour (MPH) limit will remain



Dust:

- The contractor will be required to water and sweep in order to minimize construction-related dust

What to Expect During Construction



Noise:

- Some noise should be expected during allowable construction time



Access:

- Access to businesses and residences will be maintained

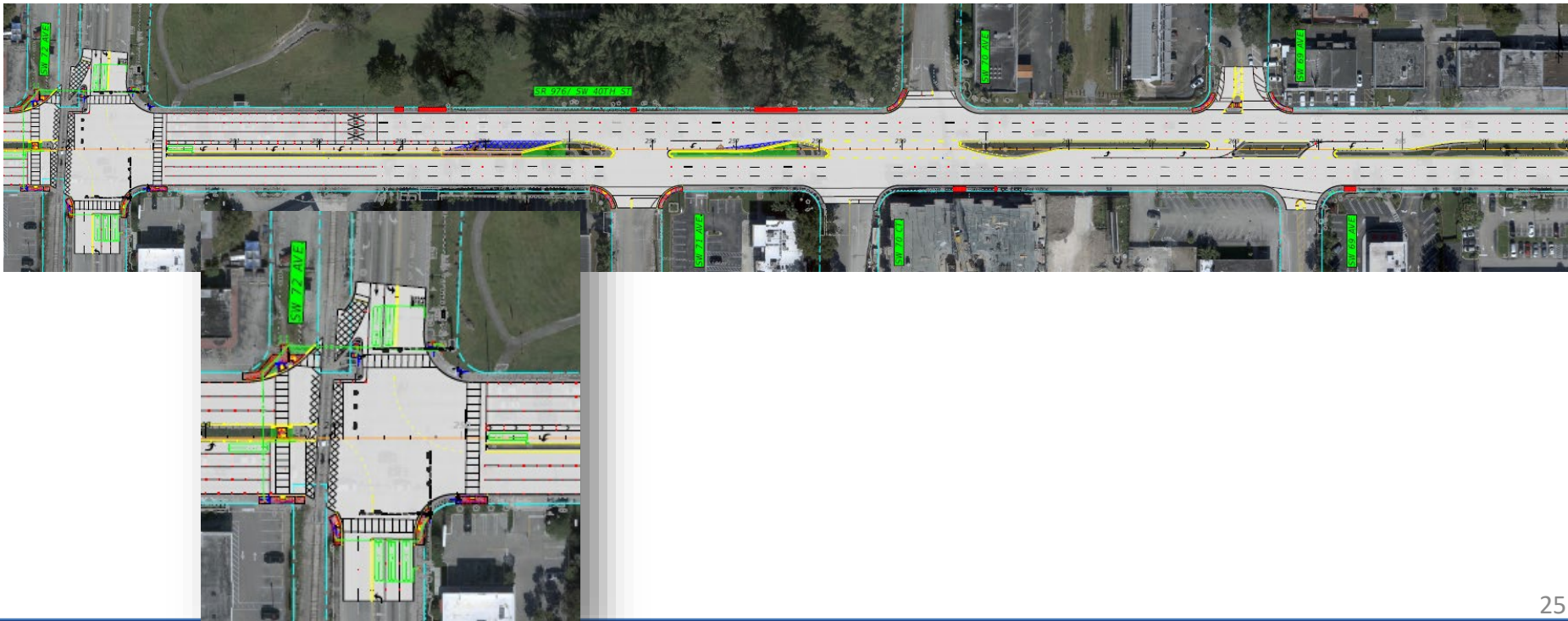


SR 976/SW 40 Street/Bird Road from SW 75 Avenue to west of SW 72 Avenue





SR 976/SW 40 Street/Bird Road from west of SW 72 Avenue to East of SW 69 Avenue



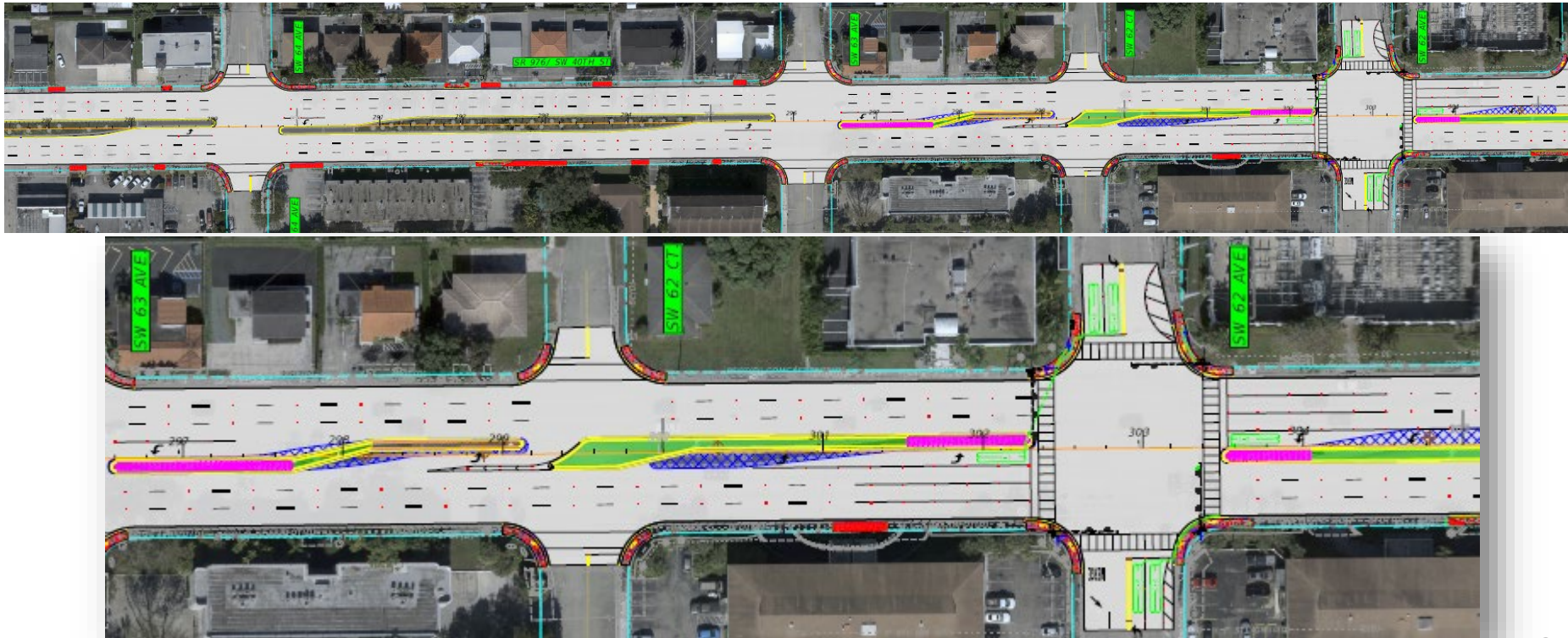


SR 976/SW 40 Street/Bird Road from east of SW 69 Avenue to east of SW 65 Avenue



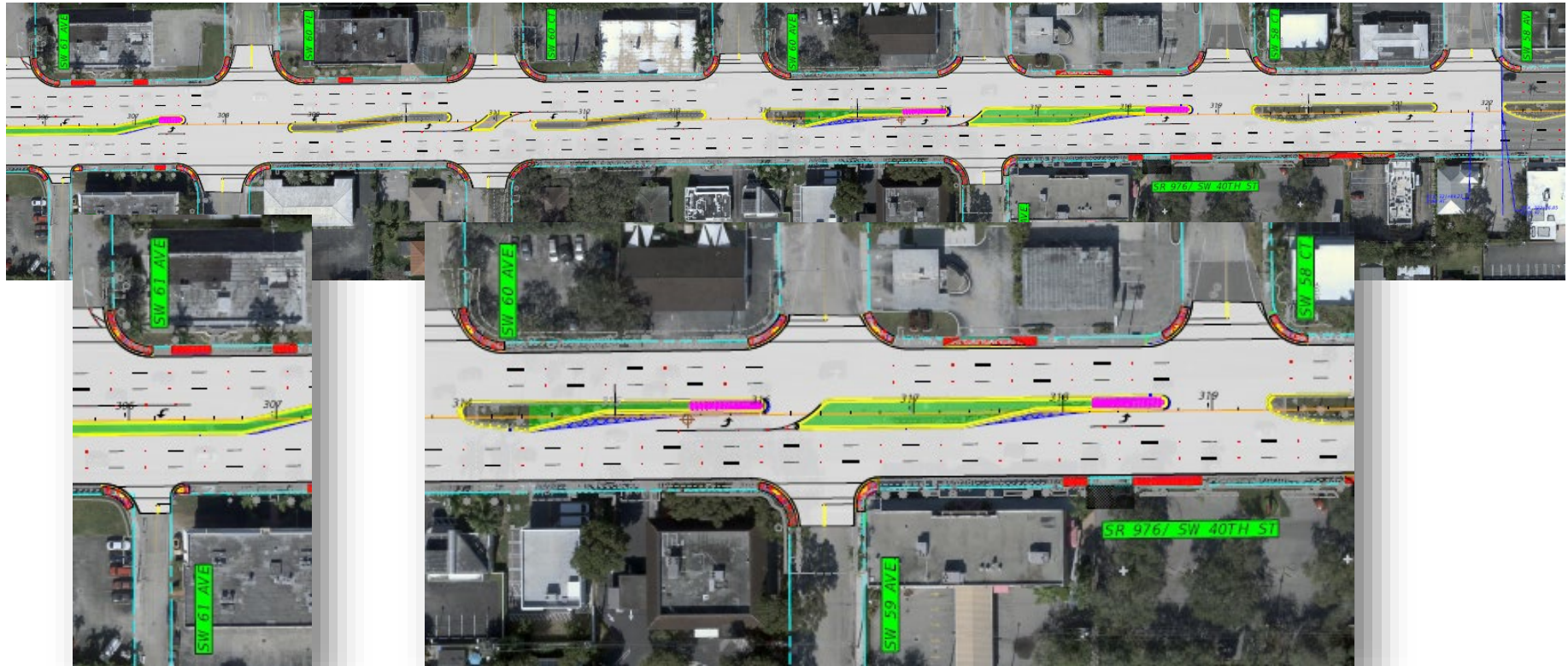


SR 976/SW 40 Street/Bird Road from east of SW 65 Ave to east of SW 62 Avenue
