

- Adjusting manholes
- Upgrading guardrail
- Reconstructing driveways
- Enhancing crosswalks along SR 5/US 1 signalized intersections


Location Map

SR 5/US 1 from SW 264 Street to SW 112 Avenue






SR 5/US 1 at SW 264 Street




SR 5/US 1 at SW 260 Street













SR 5/US 1 at SW 131 Avenue





What to Expect During Construction

Maintenance of Traffic (MOT):



- Lane closures shall occur only during non-peak hours or on non-event days/weekends
- At least one travel lane will remain open at all times

Non-peak hours are:

- 9 a.m. to 3:30 p.m. weekdays and weekends
- 9 p.m. to 7 a.m. weekdays and weekends

What to Expect During Construction



Access will always remain for vehicles, bicycles and pedestrians.

- Phase one: Working on sidewalks, drainage, signals, and driveways
- Phase two: Working on median and sidewalks
- Phase three: Repaving and resurfacing



Bicyclists:

 Bicyclists will share the outside lane with traffic or use the paved shoulder when not in conflict with the work zone.



Pedestrian:

 Pedestrian will follow posted detours when work is conducted on a sidewalk segment.



What to Expect During Construction



Posted Speed:

Existing speed limits will be maintained during construction



Dust:

The contractor will be required to water and sweep in order to minimize construction-related dust

From SW 264 Street to SW 112 Avenue FIN: 447798-1-52-01 and 447802-1-52-01

What to Expect During Construction



Noise:

Some noise should be expected during allowable construction time



Access:

Access to businesses and residences will be maintained at all times
