- Improving stormwater drainage pump system
- Repaving and restriping the road
- Upgrading vehicular signage
- Improving pedestrian curb ramps
- Adjusting manholes
- Replacing damaged sidewalks
- Enhancing pedestrian signalization








Biscayne Boulevard between NE 5 Street and NE 6 Street






Biscayne Boulevard at NE 7 Street






Biscayne Boulevard between NE 8 Street and NE 9 Street

What to Expect During Construction

Construction activities will be completed in phases to minimize impacts to the public.

Maintenance of Traffic (MOT):



- Lane closures shall occur only during non-peak hours on non-event days, nights and weekends
- At least one travel lane will remain open on Biscayne Boulevard northbound
- There will be detours for Biscayne Boulevard southbound during the stormwater drainage pump system improvement
- At least two travel lanes will remain open along Biscayne Boulevard when a detour is not provided

Non-peak hours are:

- 9 p.m. to 5:30 a.m. Sunday through Thursday
- 11 p.m. to 7 a.m. Friday and Saturday

What to Expect During Construction



Posted Speed:

Existing 30 miles per hour speed limit will be maintained during construction





 The contractor will be required to water and sweep in order to minimize construction-related dust



What to Expect During Construction



Noise:

Some noise should be expected during allowable construction time



Access:

Access to businesses and residences will be maintained at all times
