

## **Project Scope**

- Closing abandoned driveways
- Repaving and restriping the road
- Improving stormwater drainage to address ponding issues
- Adjusting manholes
- Enhancing damaged sidewalks, driveways and curb and gutter
- Upgrading vehicular signing
- Improving pedestrian signalization and crosswalks at signalized intersections
- Adding countdown pedestrian signals
- Enhancing lighting at signalized intersections
- Trimming landscape to improve intersection sight distance







#### **Communities**

FDOT is committed to developing and implementing roadway improvements that benefit this community

#### Safety

 This project will enhance safety for all road users (motorists and pedestrians) by upgrading signage and signalization

#### Resiliency

Drainage improvements will help minimize flooding






#### SR 860/NW 183 Street/Miami Gardens Drive and NW 27 Avenue



#### SR 860/NW 183 Street/Miami Gardens Drive and NW 22 Avenue




#### SR 860/NW 183 Street/Miami Gardens Drive and NW 17 Avenue






#### SR 860/NW 183 Street/Miami Gardens Drive and NW 12 Avenue








#### SR 860/NW 183 Street/Miami Gardens Drive and North Miami Avenue

# What to Expect During Construction

Construction activities will be completed in phases to minimize impacts to the public.

#### **Maintenance of Traffic (MOT):**



- Lane closures shall occur only during non-peak hours on non-event days, nights and weekends
- Two travel lanes will be maintained at most times

#### Non-peak hours are:

- 9 a.m. to 3:30 p.m. weekdays and weekends
- No work shall be allowed from 8 p.m. to 8 a.m. except for repaving and restriping



# What to Expect During Construction



#### **Posted Speed:**

 Existing 40 miles per hour speed limit will be maintained during construction



#### **Dust:**

The contractor will be required to water and sweep in order to minimize construction-related dust



# What to Expect During Construction



#### Noise:

Some noise should be expected during allowable construction time



#### Access:

Access to businesses and residences will be maintained at all times
