# FLORIDA DEPARTMENT OF TRANSPORTATION DISTRICT SIX

State Road (SR) 907/Alton Road from 43 Street to east of Allison Road

Project Identification Numbers: 430444-1/2/4-52-01

The Florida Department of Transportation (FDOT) District Six is developing the design for a roadway reconstruction project along SR 907/Alton Road from 43 Street to east of Allison Road, in Miami-Dade County. This project is broken into three segments for construction scheduling.

### **PROJECT DETAILS**

- Reconstructing and elevating the road within project limits
- Widening existing parking lanes between 43 Street and Pine Tree Drive
- Installing new pavement markings including markings for bicycle facilities
- Providing drainage improvements by designing and constructing a new roadway drainage system, including pump stations and outfalls to the Intracoastal Waterway
- Upgrading roadway lighting with new Light Emitting Diode (LED) fixtures
- Upgrading traffic signals
- Upgrading sidewalks and pedestrian ramps
- Installing bulb outs within the limits

## **ESTIMATED PROJECT COST \***

- SR 907/Alton Road from south of 43 Street to north of west 48 Street (430444-1-52-01): \$30 million
- SR 907/Alton Road from north of West 48 Street to east of Allison Road (430444-2/4-52-01): \$65 million

### **PROJECT DATES \***

- SR 907/Alton Road from south of 43 Street to north of West 48 Street (430444-1-52-01): Construction is scheduled to begin in early 2030
- SR 907/Alton Road from north of West 48 Street to east of Allison Road (430444-2/4-52-01):
  Construction is scheduled to begin in early 2030

During construction, there will be one lane of traffic on each direction opened at all time. Sidewalks will be closed at times for safety reasons. Access to driveways and entrances to residences, condominiums and businesses will remain open. Deep trenching may be required to install drainage and utilities.
