LANE CLOSURE/DETOUR INFORMATION:

During phase 3, **the inside lanes in each direction along SR 972/Coral Way will be continuously closed to completed remaining construction activities.** The outside lanes in each direction along SR 972/Coral Way and along SW 15 Road (both North and South Leg) will remain open.

As part of this phase, the following lanes will remain closed until work is complete:

- Eastbound SR 972/Coral Way to SW 15 Road (North Leg)
- SW 15 Road (North Leg to South Leg)

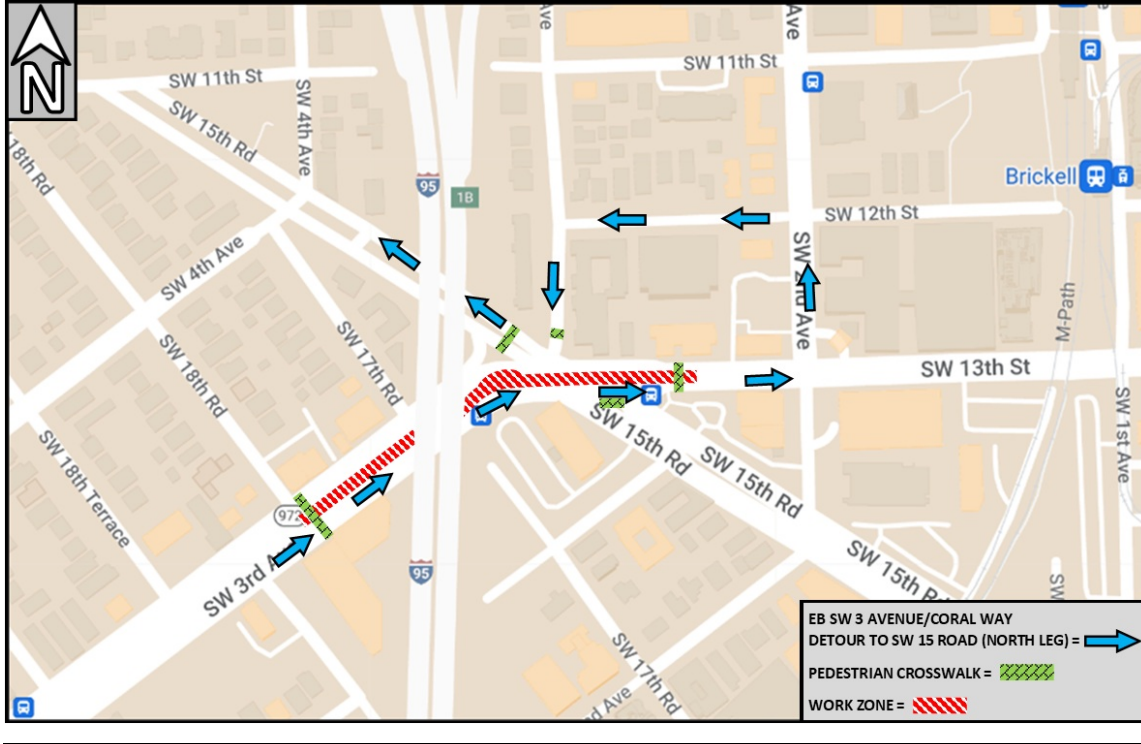

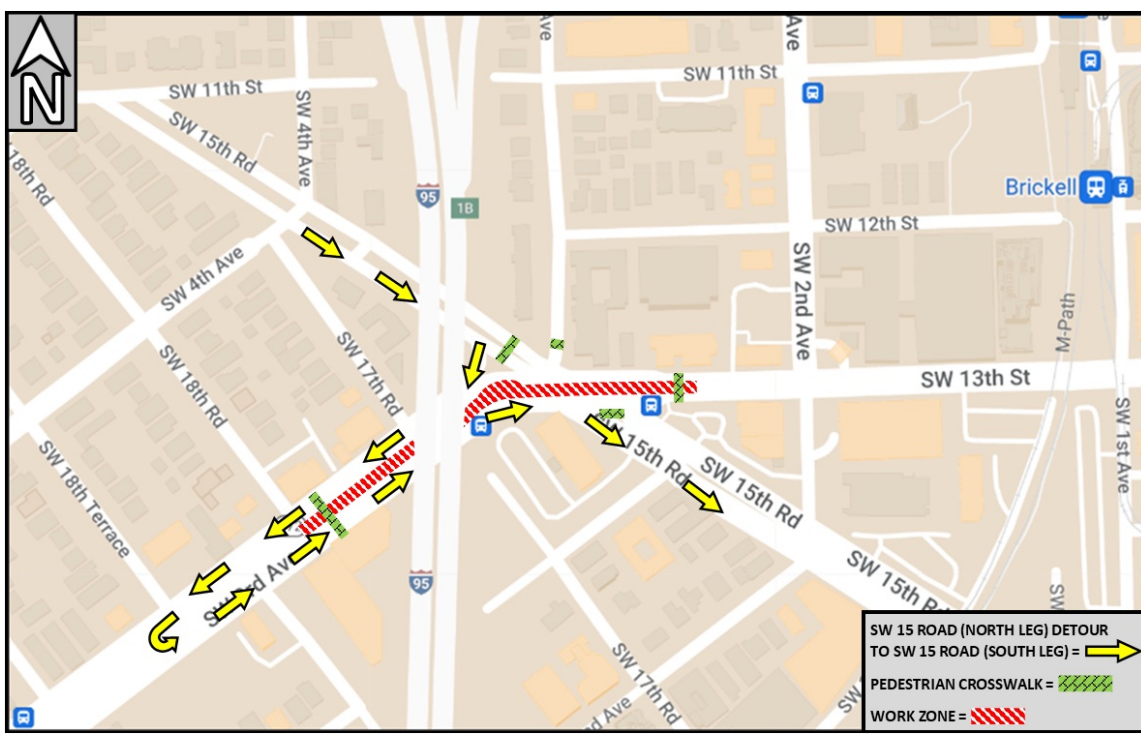
PHASE 3 MOT - EB SR 972/CORAL WAY TO SW 15 ROAD (NORTH LEG)

- Drivers will be detoured through [SW 2 Avenue \(North\)](#), [SW 12 Street \(West\)](#), and [SW 3 Avenue \(South\)](#).



PHASE 3 MOT - SW 15 ROAD (NORTH LEG TO SOUTH LEG)

- Drivers will be detoured through *SW 3 Avenue/Coral Way (West)*, make a U-turn at *SW 18 Terrace*, and continue through *SW 3 Avenue/Coral Way (East)*.



Please follow all posted signage and use caution when traveling through the construction zone and note that this schedule may change due to bad weather or other unexpected conditions.
