- Continue (as needed) nighttime roadway striping operation

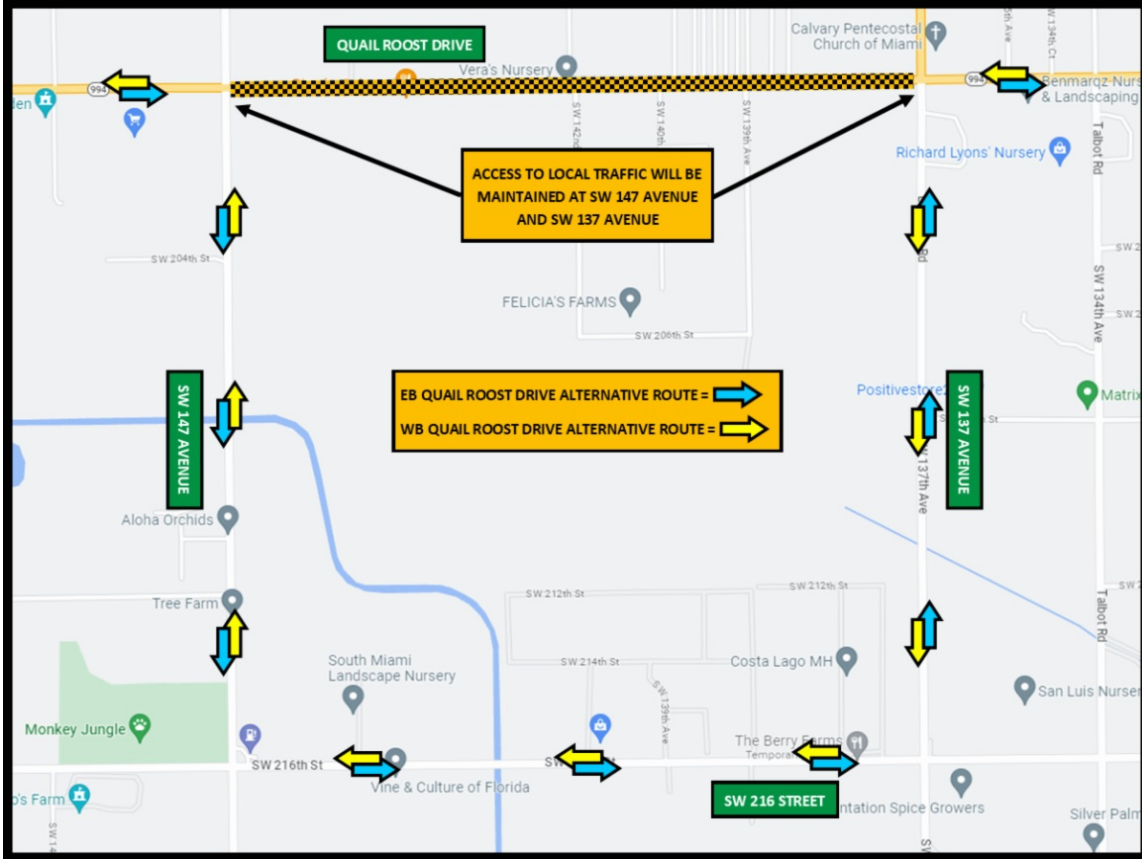
**DAYTIME LANE CLOSURES:**

- At least one eastbound and/or westbound lane of SR 994/Quail Roost Drive will be closed (***as needed***) at various locations from Krome Avenue to SW 137 Avenue, between the hours of 9 a.m. and 3:30 p.m., Monday, March 11 through Sunday, March 24, 2024.
  - *Access to local traffic along eastbound and westbound SR 994/Quail Roost Drive will be maintained at all times.*
  - *All non-local traffic must bypass the work zone from either direction of SR 994/Quail Roost Drive by using SW 216 Street as an alternate route.*

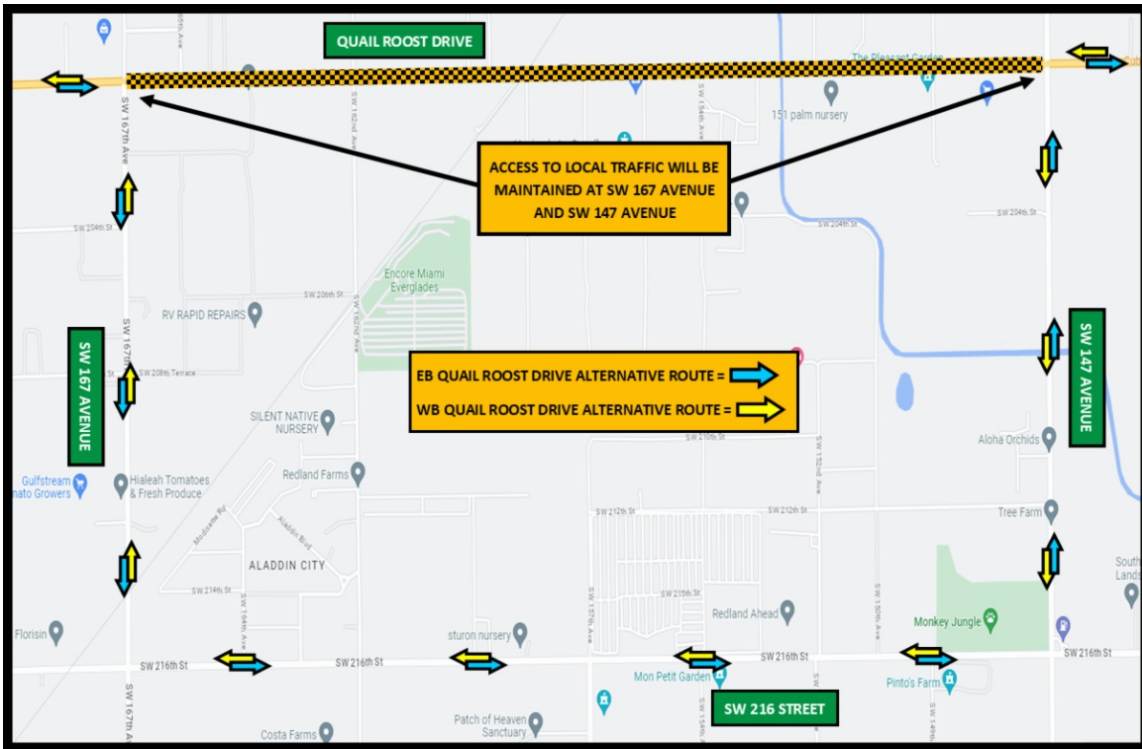
**NIGHTTIME LANE CLOSURES:**

- **During nighttime activities (7:30 p.m. to 6:30 a.m.), access to local traffic along SR 994/Quail Roost Drive will be maintained at all times.**
  - *Access to local traffic along eastbound and westbound SR 994/Quail Roost Drive will be maintained at all times.*
  - *All non-local traffic must bypass the work zone from either direction of SR 994/Quail Roost Drive by using SW 216 Street as an alternate route.*

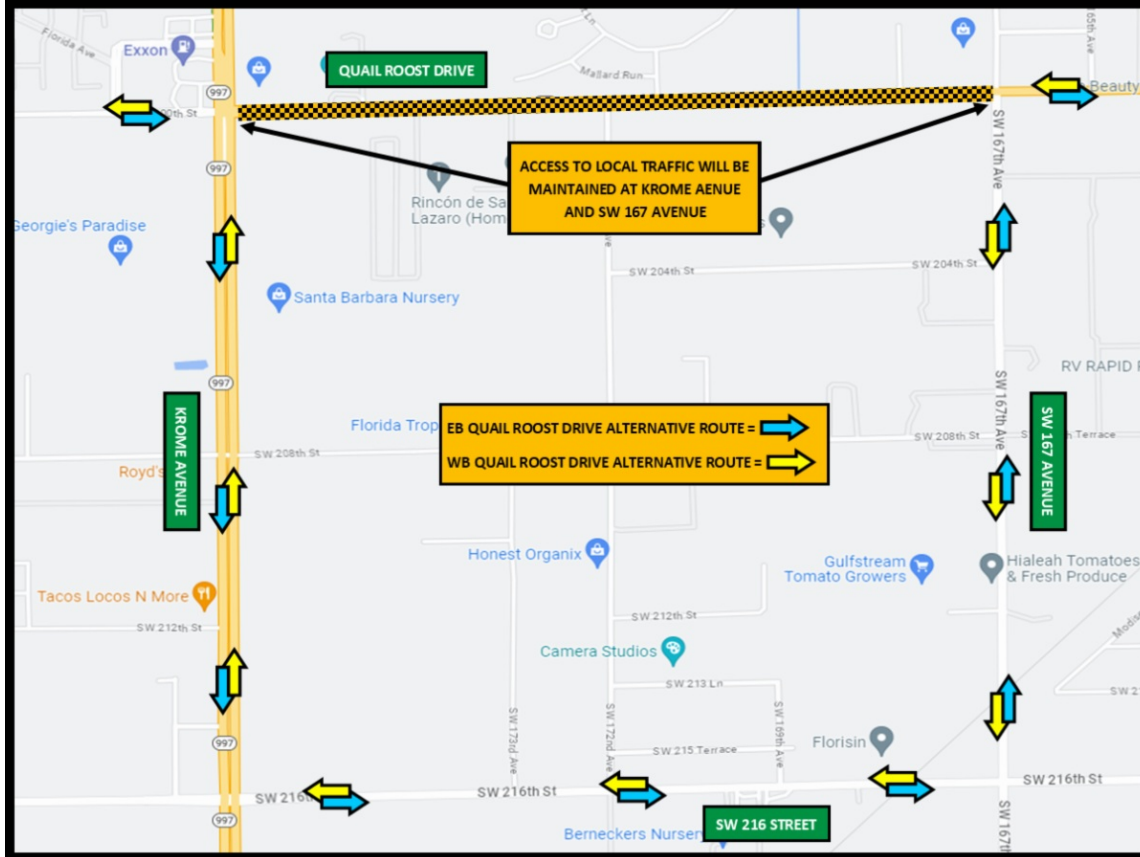
**PHASE 1: SW 137 AVENUE TO SW 147 AVENUE**
