## **FDOT to Host Public Meeting for Three Roadway Projects**

State Road (SR) 5/Overseas Highway

*Marathon, FL*– The Florida Department of Transportation (FDOT) is developing the design for three roadway improvement projects along (SR) 5/Overseas Highway in Monroe County, Florida. The first project is from south of 33 Street/MM 48.70 to 37 Street/MM 49.03. The second is from the north end of the 7 Mile Bridge to south of Knight's Key Boulevard/MM 47 and the last project is from Sombrero Beach Road/MM 50.0 to Coco Plum Drive/MM 54.6. Work for the three projects are expected to start in April 2017 and last about eight months. The combined estimated construction cost is \$2.9 million. The scope of work for these projects is listed in the enclosed public meeting notification.

A public meeting will be held from 5 p.m. to 7 p.m. on Thursday, November 5, 2015 at the Monroe County Government Center, County Commission Chamber, 2 floor, 2798 Overseas Highway, Marathon, FL 33050. The meeting will begin as an open house, from 5 p.m. to 7 p.m., with a formal presentation starting at 5:30 p.m. Graphic displays will be shown during the meeting, and FDOT representatives will be available to discuss the project.

The proposed work for these projects includes:

## 33 Street/MM 48.70 to 37 Street/MM 49.03

- Repaying and resurfacing the road
- Widening the road to add a two-way turning lane
- Modifying the intersection at 33 Street from a T intersection to a four sided intersection
- Installing new drainage, curb and gutter, and sidewalks
- Updating signage and pavement markings
- Designating the outside travel lanes to be shared with bicycles known as a "sharrow"
- Removing the existing Florida Keys Overseas Heritage Trail on the north side and removal of the asphalt sidewalk on the south side

## North of the 7 Mile Bridge to South of Knight's Key Boulevard/MM 47

- Repaying and restriping the road
- Replacing existing guardrail
- Widening the northbound shoulder and adding rumble strips
- Installing additional drainage
- Adding a pedestrian ramp at the end of the Trail
- Installing bike pavement markings to both northbound and southbound shoulders
- Updating signage to current standards
- Adding a traffic counting station

## Sombrero Beach Road MM/50.0 to Coco Plum Drive MM/54.6

- Installing additional signal heads at various intersections
- Enhancing existing signal heads at Coco Plum Drive
- Replacing the traffic signal controller at 89 street and Coco Plum Drive
