**Florida Department of Transportation to Hold Transit Technologies
Analysis Public Meetings on NW 27 Avenue Premium Transit Study**
*State Road (SR) 9/SR 817/NW 27 Avenue from NW 215 Street
to the Miami Intermodal Center (MIC)*

Miami, FL – The Florida Department of Transportation (FDOT) District Six, has scheduled Transit Technologies Analysis Public Meetings for the proposed improvements along SR 9/SR 817/NW 27 Avenue from NW 38 Street to NW 215 Street (at Unity Station) and from the MIC (at Miami International Airport) to NW 27 Avenue via SR 112 in Miami-Dade County. The Public Meetings will be held **on Tuesday, September 17, 2019, from 6:30 p.m. to 8:30 p.m. at the Betty T. Ferguson Recreational Complex Auditorium, located at 3000 NW 199 Street, Miami Gardens, FL 33056 and on Thursday, September 19, 2019 from 6:30 a.m. to 8:30 p.m. at the Joseph Caleb Center – Meeting Room 110, located at 5400 NW 22 Avenue, Miami, FL 33142.** (Please enter from the North Entrance located on NW 56 Street and park in the garage.)

The study has focused on implementation of a Rapid Transit service and infrastructure along SR 9/SR 817/NW 27 Avenue. The study also included public on-street transit stations/stops as well as public and/or private facilities located adjacent to or off-corridor where potential park-and-ride and/or transit terminals (including the Miami Dade College North Campus) will be considered. These public meetings are being held to discuss the transit technologies analysis and obtain comments. Department representatives will be available during the public meeting to informally discuss the project and answer questions.

Public participation at these meetings is solicited without regard to race, color, national origin, age, sex, religion, disability or family status.
