Roadway, Signage Improvement Project Grouping Begins Week of October 7

Locations on State Road (SR) 9A/I-95, SR 112/I-195

Miami, Fla. – The Florida Department of Transportation (FDOT) is scheduled to begin a new roadway and signage improvement project grouping the week of October 7, 2019. The project includes select locations throughout the City of Miami and City of Miami Beach. The project limits extend along the SR 9A/I-95 entrance ramp at NW 10 Avenue, the SR 112/I-195 entrance and exit ramps at SR 907/Alton Road and the SR 112/I-195 eastbound ramp to SR 907/Alton Road. The combined project cost is an estimated \$1 million. The work will take about six months to be completed.

The work along the SR 9A/I-95 entrance ramp at NW 10 Avenue includes repaving and restriping the entrance to I-95 northbound Express Lanes from NW 10 Avenue to the first bridge on the ramp; upgrading the pedestrian ramps at NW 10 Avenue; constructing an end taper for the barrier wall; and enhancing existing traffic signs. The work along the SR 112/I-195 entrance and exit ramps at SR 907/Alton Road includes repaving and restriping the exit ramp from eastbound I-195 to northbound Alton Road and the entrance ramp from northbound Alton Road to westbound I-195; rebuilding and widening shoulder pavement; enhancing signing and pavement markings; upgrading guardrail, guardrail terminals and existing signs; and installing barrier wall. The work along the SR 112/I-195 eastbound ramp to SR 907/Alton Road includes replacing an overhead sign structure.

To build this project safely, it will be necessary to periodically close lanes. Construction will be done in stages to minimize impacts to the public during special events and peak periods of traffic. The department will make sure traffic continues to flow safely through the work zones.
