FDOT Golden Glades Interchange (GGI) Project Lane and Ramp Closures & Detours

Sunday, April 21 to Friday, April 26

MIAMI, Fla. – The following ramp and lane closures are scheduled between Sunday, April 21, and Friday, April 26, 2024.

Ramp closures:

From **Sunday, April 21, to Friday, April 26**, from 11 p.m. to 5 a.m., the ramps listed below will be closed:

1. Ramp from southbound Turnpike to southbound I-95
 2. Ramp from eastbound State Road (SR) 826/Palmetto Expressway to NW 167 Street
 3. Ramp from eastbound Palmetto Expressway to NW 7 Avenue Extension
 4. Ramp from eastbound Palmetto Expressway to northbound Turnpike
 5. Ramp from northbound SR 9 to westbound Palmetto Expressway
 6. Ramp from northbound SR 9 to northbound Turnpike
 7. Ramp from northbound I-95 to westbound Palmetto Expressway
 8. Ramp from westbound NW 167 Street to westbound Palmetto Expressway
 9. Ramp from southbound I-95 to westbound Palmetto Expressway
1. Drivers going south on the Turnpike, who want to go south on I-95 will be detoured as follows:
 - Continue south on the Turnpike to exit at NW 167 Street
 - Turn right onto southbound NE 6 Avenue
 - Turn right onto westbound Opa-locka Boulevard
 - Take the ramp for southbound I-95
 2. Drivers going east on the Palmetto Expressway, who want to go east to NW 167 Street will be detoured as follows:

- Continue east and take the ramp to I-95 and southbound SR 7/US 441/NW 7 Avenue
 - Exit at NW 7 Avenue and turn right onto northbound NW 7 Avenue
 - Take the ramp to SR 826 Beaches for NW 167 Street
3. Drivers going east on the Palmetto Expressway, who want to continue east to NW 7 Avenue Extension will be detoured as follows:
- Continue east and take the ramp to I-95 and southbound SR 7/US 441/NW 7 Avenue
 - Exit at NW 7 Avenue and turn right onto northbound NW 7 Avenue
 - Take the ramp to northbound SR 7/US 441/NW 2 Avenue
 - Continue north and make a left for NW 7 Avenue Extension
4. Drivers going east on the Palmetto Expressway, who want to go north on the Turnpike will be detoured as follows:
- Continue east and take the ramp to I-95 and southbound SR 7/US 441/NW 7 Avenue
 - Exit at NW 7 Avenue and turn right onto northbound NW 7 Avenue
 - Take the ramp to northbound SR 7/US 441/NW 2 Avenue
 - Continue north and make a left onto westbound NW 7 Avenue Extension
 - Take the ramp to northbound Turnpike
5. Drivers going north on SR 9 or SR 7/US 441/NW 7 Avenue, who want to go west on the Palmetto Expressway will be detoured as follows:
- Continue north and take the ramp to northbound SR 7/US 441/NW 2 Avenue
 - Continue north on NW 2 Avenue and turn left onto westbound NW 183 Street/Miami Gardens Drive
 - Turn left onto southbound NW 27 Avenue
 - Take the ramp to westbound Palmetto Expressway
6. Drivers going north on SR 9 or SR 7/US 441/NW 7 Avenue, who want to go north on Florida's Turnpike will be detoured as follows:
- Continue north and take the ramp to northbound SR 7/US 441/NW 2 Avenue
 - Turn left onto westbound NW 7 Avenue Extension
 - Take the ramp to northbound Turnpike
7. Drivers going north on I-95, who want to go west on the Palmetto Expressway will be detoured as follows:
- Continue north on I-95 and take the ramp to SR 7/US 441/NW 2 Avenue
 - Continue north on NW 2 Avenue and turn left onto westbound NW 183 Street/Miami Gardens Drive
 - Turn left onto southbound NW 27 Avenue

- Take the ramp to westbound Palmetto Expressway
8. Drivers going west on NW 167 Street, who want to go west on the Palmetto Expressway will be detoured as follows:
- Take the ramp to northbound SR 7/US 441/NW 2 Avenue
 - Continue north on NW 2 Avenue and turn left onto westbound NW 183 Street/Miami Gardens Drive
 - Turn left onto southbound NW 27 Avenue
 - Take the ramp to westbound Palmetto Expressway
9. Drivers going south on I-95, who want to go west on the Palmetto Expressway will be detoured as follows:
- Take Exit 12 to the Turnpike
 - Continue north on the Turnpike and exit at NW 199 Street
 - Turn left onto eastbound NW 199 Street
 - Take the ramp to southbound Turnpike
 - Continue south on the Turnpike and take the ramp to westbound Palmetto Expressway

On **Thursday, April 25**, from 11 p.m. to 5 a.m., the ramp from eastbound Palmetto Expressway to southbound I-95 will be closed and traffic will be detoured as follows:

- Continue east on Palmetto Expressway to NW 7 Avenue Extension
- Turn right onto SR 7/US 441/NW 2 Avenue
- Take the ramp on the left-hand side for southbound I-95

These lane closures below will occur nightly as needed:

I-95 between NW 135 Street and the Golden Glades Interchange

- From 11 p.m. to 5 a.m., up to two lanes in both directions will be closed as needed.

Palmetto Expressway between NW 12 Avenue and NW 7 Avenue Extension

- At 9 p.m., one lane in both directions will be closed as needed.
- At 11 p.m., a second lane in both directions will be closed as needed.

Florida's Turnpike between NW 183 Street/Miami Gardens Drive and I-95

- From 9 p.m. to 5 a.m., up to two lanes in both directions will be closed as needed.

All lanes and ramps will reopen at 5 a.m. These closures will allow crews to perform bridge work, roadway paving and temporary concrete barrier wall installation. Please note this schedule may change due to bad weather or other unexpected conditions.
