## State Road (SR) 922/NE 123 Street Design Project Public Meeting

March 23, 2022

**MIAMI, Fla.** – The Florida Department of Transportation (FDOT) District Six will host a meeting, both in-person and virtually, for a roadway project along SR 922/NE 123 Street from NE 16 Avenue to NE 19 Avenue starting at 6 p.m. on Wednesday, March 23, 2022.

The proposed improvements include: repaving and restriping the roadway; widening for additional westbound left-turn lane and modifying the traffic median; adjusting manholes; adding a new traffic signal at the NW corner of SR 5/US 1 and NE 123 Street; upgrading curb ramps, pedestrian signals and crosswalk pavement markings to high emphasis; extending the westbound right-turn lane; upgrading traffic signage and pavement markings; eliminating westbound left-turn access to NE 18 Avenue southbound and relocating four palm trees located on the westbound approach due to widening.

Construction is expected to begin fall 2024 and last about six months. The estimated construction cost for this project is \$949,213.

The meeting will consist of a formal presentation followed by an open discussion. Staff will be available to answer questions in the order they are received and as time permits. If your question is not responded to during the meeting, a response will be provided in writing afterwards.
