FDOT to Host State Road (SR) A1A and SR 112 Design Project Public Meeting

July 11, 2023

MIAMI, Fla. – The Florida Department of Transportation (FDOT) will host a meeting, both in-person and virtually, for a roadway and bridge project along (SR) A1A/Collins Avenue from 44 Street to 4700 Block and Indian Creek from 41 Street to 44 Street and SR 112/W 41 Street over the Indian Creek Waterway Bridge, starting at 6 p.m. on Tuesday, July 11, 2023.

SR A1A/Collins Avenue from 44 Street to 4700 Block and Indian Creek from 41 Street to 44 Street:

The proposed improvements include: removing to add a second right turn lane from southbound Indian Creek Drive to westbound 41 Street; adding signalization at 41 Street for the southbound dual right turn lanes; upgrading pedestrian ramps to meet the American with Disability Act (ADA) standards and crossings at signalized intersections; reconstructing damaged sidewalk and curb and gutter; adjusting manholes and valves; removing parking upgrading signage; upgrading bicycle lane; relocating or trimming existing landscape and fixing stormwater drainage inlets.

SR 112/W 41 Street over the Indian Creek Waterway Bridge:

The proposed improvements include: repairing the bridge deck; rehabilitating the bridge features above and below including handrails, columns, etc.; replacing deck expansion joints and rehabilitating the bridge foundation.

Construction is scheduled to start summer 2024 and last about one year. The estimated combined construction cost for this project is \$6 million.

The meeting will consist of a formal presentation followed by an open discussion. Staff will be available to answer questions in the order they are received and as time permits.

If your question is not responded to during the meeting, a response will be provided in writing afterwards.
