### **FDOT to Host Public Meeting for State Road (SR) 915/NE 6 Avenue Projects** *August 25, 2021*

**MIAMI, Fla.** – The Florida Department of Transportation (FDOT) District Six will host a meeting, both in-person and virtually, for two roadway projects along SR 915/NE 6 Avenue from NE 123 Street to NE 145 Street from 6 p.m. to 7:30 p.m. on Wednesday, August 25, 2021.

#### **In-Person Public Meeting will be held at:**

The proposed improvements, lengths and costs of each project is below:

#### **SR 915/NE 6 Avenue from NE 123 Street to NE 145 Street:**

The proposed improvements include repaving and restriping the roadway; reconstructing damaged sidewalk and curb and gutter; closing two abandoned driveways; modifying the median from NE 135 Street to NE 145 Street; upgrading signing and pavement markings; upgrading pedestrian signals and Improving lighting at the mid-block pedestrian crossings located north of NE 136 Street.

Construction is expected to begin in February 2023 and last about ten months. The estimated construction cost for this project is \$2.5 million.

#### **SR 915/NE 6 Avenue at NE 139 Street:**

The proposed improvements include repaving and restriping the roadway and upgrading pavement markings; installing a signalized intersection; constructing curb ramps; replacing sidewalk impacted by the proposed traffic light; installing new signing and pavement markings and upgrading lighting.

Construction is expected to begin February 2023 and last about five months. The estimated construction cost for this project is \$508,111.

The meeting will consist of a formal presentation followed by an open discussion. Staff will be available to answer questions in the order they are received and as time permits. If your question is not responded to during the meeting, a response will be provided in writing afterwards.
