### FDOT to Host State Road (SR) A1A/Collins Avenue Design Project Virtual Public Meeting

May 26, 2021

**MIAMI, Fla.** – The Florida Department of Transportation (FDOT) District Six will host a Virtual Public Meeting for a roadway improvement project along SR A1A/Collins Avenue from 26 Street to 44 Street/Indian Creek Drive from 6 p.m. to 7:30 p.m. on Wednesday, May 26, 2021 via GoToWebinar.

Proposed improvements include: repaving and restriping the roadway; adjusting manholes; upgrading signs and pavement markings; reconstructing damaged sidewalks, curb ramps and curb and gutter; upgrading crosswalks; adding “sharrow” pavement markings to the outside lane; trimming trees and shrubs away from the roadway and sidewalks; relocating some light poles; upgrading pedestrian signs and push-buttons; removing three parking spaces between 38 Street and 39 Street at the crosswalk location; improving drainage; adding overhead signs before the 44 Street/Indian Creek Drive signal and widening the roadway just before the 44 Street/Indian Creek Drive signal to provide two left turn lanes and two right turn lanes. Construction is expected to begin in May 2023 and last about nine months. The estimated construction cost for this project is \$3.1 million.
