### **Closures on I-95, I-395, SR 836 and Adjacent Ramps**

**MIAMI, Fla.** – The following closures on I-95, I-395, SR 836, adjacent ramps and local roads will be scheduled as noted below:

#### **I-95 Closures**

- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - Up to four lanes on southbound I-95 from NW 29 Street to NW 8 Street will be closed between the hours of 9 p.m. and 5:30 a.m.
- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - Up to four lanes on northbound I-95 will be closed nightly from NW 8 Street to NW 29 Street between the hours of 9 p.m. and 5:30 a.m.

#### **Closure of Northbound I-95 Ramp to I-195 East/Miami Beach (Exit 4A)**

- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - The northbound I-95 ramp to I-195 East/Miami Beach (Exit 4A) will be closed between the hours of 9 p.m. and 5:30 a.m. Drivers can continue north on I-95 to access the I-195 East/Miami Beach ramp (Exit 4B) located north of NW 32 Street.

#### **Southbound I-95 Ramp to Eastbound I-395 Detour**

- Thursday, June 3 and Tuesday, June 8 - The southbound I-95 ramp to eastbound I-395 will be closed as needed between the hours of 9 p.m. and 5:30 a.m. Drivers can:
  - Continue south on I-95, exit at the NW 8 Street ramp (Exit 3B)
  - Turn left on NW 8 Street, continue east on NW 8 Street
  - Turn left at Biscayne Boulevard to access the A1A North/Miami Beach Ramp

#### **Northbound I-95 Ramp to Westbound SR 836 Detour**

- Thursday, June 3, Monday, June 7, Wednesday, June 9 and Thursday, June 10 - The northbound I-95 ramp to westbound SR 836 will be closed between the hours of 10 p.m. and 5:30 a.m. Drivers can:
  - Enter the eastbound I-395 ramp
  - Exit at NE 2 Avenue/Biscayne Boulevard (Exit 2B), then turn right on NE 2 Avenue
  - Turn right on NE 11 Street
  - Turn right on NE 1 Avenue to access westbound I-395 to continue onto westbound SR 836

### **NW 17 Street Daytime Closures Under I-95**

- Thursday, June 3, Friday, June 4 and Monday, June 7 through Thursday, June 10 - One lane on westbound NW 17 Street under I-95 will be closed as needed between the hours of 7 a.m. and 6 p.m. to allow contractor to work on bridge foundations. Traffic will be flagged around the work zone.

### **I-395 Mainline Lane Closures**

- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - One lane on mainline eastbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.
- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - One lane on mainline westbound I-395 will be closed from I-95 to Biscayne Boulevard between the hours of 10 p.m. and 5:30 a.m.

### **Daytime North Miami Avenue Lane Closures**

- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - Up to two lanes on North Miami Avenue will be closed as needed between the hours of 9 a.m. to 3:30 p.m. to allow the contractor to widen the roadway for an upcoming traffic shift.

### **Daytime Lane Closure on Biscayne Boulevard**

- Wednesday, June 9 and Thursday, June 10 - One northbound lane on Biscayne Boulevard from NE 11 Terrace to NW 13 Street will be closed between the hours of 9 a.m. and 3:30 p.m. for drainage work.

### **Nighttime NE 1 Avenue Lane Closure**

- Thursday, June 3 - One lane on northbound NE 1 Avenue from I-395 to NE 13 Street will be closed between the hours of 9 a.m. to 3:30 p.m. to allow the contractor to drive sheet pile adjacent to the roadway.

### **Closure of NW 14 Terrace**

- NW 14 Terrace will be closed from NW 3 Avenue to NW 2 Avenue until further notice to allow the contractor to construct bridge foundations. Drivers can use NW 15 Street as an alternate.

### **Nighttime Closure of the NW 3 Avenue/NW 14 Street Intersection for Bridge Segment Erection**

- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - The NW 3 Avenue/NW 14 Street intersection will be closed between the hours of 10 p.m. and 5:30 a.m. to allow the contractor to place bridge segments over the roadway.
  - Northbound drivers on NW 3 Avenue can:
    - Turn right on NW 13 Street, then turn left on NW 1 Place
    - Turn right on NW 14 Street, then turn left on NW 1 Avenue
    - Turn left on NW 16 Street to connect with NW 3 Avenue
  - Southbound drivers on NW 3 Avenue can:
    - Turn left on NW 16 Street, then turn right on NW 2 Avenue
    - Turn left on NW 15 Street, then turn right on NW 1 Avenue
    - Turn left on NW 14 Street, then turn right on North Miami Avenue
    - Turn right on NW 11 Street to connect with NW 3 Avenue
  - Eastbound drivers on NW 14 Street can:

- Turn left on NW 7 Avenue, then turn right on NW 17 Street
- Turn right on NW 1 Avenue to connect with NW 14 Street
- Westbound drivers on NW 14 Street can:
  - Turn right on NW 1 Avenue, then turn left on NW 17 Street
  - Turn left on NW 7 Avenue to connect with NW 14 Street

### **Closure of NW 13 Street at NW 1 Court**

- A section of NW 13 Street at NW 1 Court will be closed until further notice. The closure will allow the contractor to construct bridge caps for the new I-395 bridges.

### **Long-Term Closure of NW 1 Court**

- NW 1 Court from NW 13 Street to NW 14 Street and NW 13 Street from NW 1 Avenue to NW 1 Court will remain continuously closed until further notice to allow the contractor to work on bridges over the roadways.

### **SR 836 Lane Closures**

- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - Up to two lanes on eastbound SR 836 from NW 17 Avenue to I-95 will be closed as needed between the hours of 9 p.m. and 5:30 a.m.
- Thursday, June 3 and Sunday, June 6 through Thursday, June 10 - Up to two westbound lanes on SR 836 from I-95 to NW 17 Avenue will be closed as needed between the hours of 9 p.m. and 5:30 a.m.

### **Eastbound SR 836 Ramp to Northbound I-95 Detour**

- Thursday, June 3 and Thursday, June 10 - The eastbound SR 836 ramp to northbound I-95 will be closed as needed between the hours of 10:30 p.m. and 5:30 a.m. Drivers can:
  - Access the southbound I-95/NW 8 Street ramp, then exit at the NW 8 Street/PortMiami ramp
  - Turn left at NW 8 Street
  - Turn left at NW 3 Avenue to access the northbound I-95 ramp

### **Southbound NW 12 Avenue Ramp to Eastbound SR 836 Detour**

- Monday, June 7- The southbound NW 12 Avenue ramp to eastbound SR 836 will be closed as needed between the hours of 10 p.m. and 5:30 a.m. Drivers can:
  - Turn right on NW 14 Street
  - Turn left on NW 14 Avenue and continue along NW 11 Street
  - Turn left on NW 12 Avenue to access the SR 836 east entrance ramp

### **Northbound NW 12 Avenue Ramp to Eastbound SR 836 Detour**

- Thursday, June 3 and Sunday, June 6 - The northbound NW 12 Avenue ramp to eastbound SR 836 will be closed as needed between the hours of 10 p.m. and 5:30 a.m. Drivers can:
  - Continue north on NW 12 Avenue, then turn left on NW 12 Street
  - Turn right on NW 13 Avenue, then turn right on NW 14 Street
  - Turn right on NW 12 Avenue to access the southbound NW 12 Avenue entrance ramp to SR 836 east

### **Southbound NW 17 Avenue Ramp to Westbound SR 836 Detour**

- Sunday, June 6 through Thursday, June 10 -The southbound NW 17 Avenue ramp to westbound SR 836 will be closed between the hours of 9 p.m. and 5:30 a.m. Drivers can:
  - Continue south on NW 17 Avenue, then turn right on NW 7 Street
  - Turn right on NW 27 Avenue to access the westbound SR 836 ramp

### **NW 7 Avenue Lane Closure**

- Thursday, June 3, Friday, June 4 and Sunday, June 6 through Thursday, June 10 - One northbound lane on NW 7 Avenue will be closed from NW 15 Street to NW 14 Street between the hours of 9 a.m. and 3:30 p.m. to allow the contractor to work on bridge piers and caps. The sidewalk on the east side of NW 7 Avenue will also be closed during this period and pedestrians will be detoured to the sidewalk on the west side.

Please note that this schedule may change due to bad weather or other unforeseen conditions.

The work is part of the I-395/SR 836/I-95 Design-Build Project that will reconstruct the I-395 corridor from the SR 836/I-395/I-95 (Midtown) Interchange to the MacArthur Causeway Bridge, including the construction of a Signature Bridge over NE 2 Avenue and Biscayne Boulevard; double-deck SR 836 from west of NW 17 Avenue to the Midtown Interchange and the replacement of the concrete pavement on I-95 from NW 8 Street to NW 29 Street.
