Northbound 95 Express Entrance Being Relocated, Plastic Pole Installation Begins April 9

Approximately one mile south to NW 29 Street

MIAMI, Fla. – Beginning on Sunday, April 9, workers for the I-395/SR 836/I-95 Design-Build Project will begin installing additional plastic poles along the northbound 95 Express Lanes to move the entrance point back to its original location, approximately one mile south of the current entrance as shown [here](#).

The installation of the poles is expected to be completed in one to two nights. To complete the pole installation, the following closures will be implemented:

- **Sunday, April 9 (and Monday, April 10, if needed)** - All northbound 95 Express lanes will be closed from I-195/SR 112 to the Golden Glades Interchange and one northbound general purpose lane will be closed from north of I-195/SR 112 to south of NW 29 Street between 9 p.m. and 5:30 a.m.

The roadway striping and overhead signs have already been modified to reflect the permanent location of the northbound 95 Express entrance. Overhead and trailer-mounted message boards are being used to alert drivers to the new entrance. Drivers should not cross the double white lines or drive through the plastic poles to get in or out of the express lanes.

Installation of the poles on southbound 95 Express was completed on Monday, April 3. The 95 Express entrance and exit points were temporarily relocated due to concrete replacement in the area, which has been completed. The work is part of the I-395/SR 836/I-95 Design-Build Project that will reconstruct the I-395 corridor from the SR 836/I-395/I-95 (Midtown) Interchange to the MacArthur Causeway Bridge.
