State Road (SR) 7/NW 2 Avenue Nighttime Lane Closures Begin October 26

Between SR 860/NW 183 Street/Miami Gardens Drive and NW 188 Street

MIAMI, Fla. – Beginning Wednesday, October 26 through Thursday, November 3, travel lanes along SR 7/NW 2 Avenue between NW 183 Street/Miami Gardens Drive and NW 188 Street will be closed as needed between the hours of 9 p.m. and 5:30 a.m., while workers remove existing traffic signal mast arms at the intersection of SR 7/NW 2 Avenue and NW 183 Street/Miami Gardens Drive. During this operation, travel lanes will be closed in one direction for up to 10 minutes. Law enforcement will assist with directing traffic through the area.

Beginning Sunday, October 30 through Thursday, November 3, crews will repave the road in this area. During paving, at least one travel lane will be closed in each direction between 9 p.m. and 5:30 a.m.

Drivers might experience delays traveling through the area and should seek alternate routes if possible. **Please use caution when traveling through construction zones and note that this schedule may change due to bad weather or other unexpected conditions.**

This work is part of the ongoing FDOT roadway project along SR 7/NW 2 Avenue from SR 860/NW 183 Street/Miami Gardens Drive to NW 188 Street.
