### **State Road (SR) 826/Palmetto Expressway Ramp Closures at SR 817/NW 27 Avenue Begin April 22**

**MIAMI, Fla.** – Beginning Monday, April 22 through Wednesday, April 24, the on and off-ramps of SR 826/Palmetto Expressway at SR 817/NW 27 Avenue will be closed as needed between the hours of 9 p.m. and 6 a.m., to repave the ramps. Only one ramp will be closed at a time.

During ramp closures, the following detours will be implemented:

- **Eastbound SR 826/Palmetto Expressway Off-Ramp to NW 27 Avenue:**  
*Motorists will be detoured to exit at NW 17 Avenue and proceed to NW 167 Street to access NW 27 Avenue.*
- **Eastbound SR 826/Palmetto Expressway On-Ramp from NW 27 Avenue:**  
*Motorists will be detoured to NW 167 Street and make U-turn at NW 37 Avenue to access eastbound SR 826/Palmetto Expressway.*
- **Westbound SR 826/Palmetto Expressway Off-Ramp to NW 27 Avenue:**  
*Motorists will be detoured to exit at NW 37 Avenue and proceed to NW 167 Street to access NW 27 Avenue.*
- **Westbound SR 826/Palmetto Expressway On-Ramp from NW 27 Avenue:**  
*Motorists will be detours to NW 167 Street and make a u-turn at NW 17 Avenue to access westbound SR 826/Palmetto Expressway.*

Law enforcement officers will be on-site to assist with traffic. Drivers might experience delays traveling through the area and should seek alternate routes if possible. Please use caution when traveling through construction zones.

**Please follow all posted signage and note that this schedule may change due to bad weather or other unexpected conditions.**

This operation is part of the ongoing FDOT project along SR 817/NW 27 Avenue from NW 135 Street to NW 187 Avenue.
