State Road (SR) 9A/I-95 and SR 970/SR 5 Downtown Distributor Ramp Projects Public Meeting *May 10, 2022*

MIAMI, Fla. – The Florida Department of Transportation (FDOT) District Six will host a meeting, both in-person and virtually, for two roadway projects along SR 970/SR 5/Downtown Distributor Ramps from South Miami Avenue to SE 2 Avenue and along SR 9A/I-95 from SR 90/SW 8 Street to SR 5/US 1/S Dixie Highway starting at 6 p.m. on Tuesday, May 10, 2022.

SR 970/SR 5/Downtown Distributor Ramps from South Miami Avenue to SE 2 Avenue: The proposed improvements include rehabilitating the concrete pavement; repaving and restriping the roadway; reconstructing guardrail; adjusting manholes; upgrading existing damaged curb and gutter and pavement markings; reconstructing damaged sidewalks at pedestrian crossings; upgrading signage; trimming landscape and providing crosswalks and countdown signals with push buttons. Construction is expected to begin September 2023 and last about one year. The estimated construction cost for this project is \$1.7 million.

SR 9A/I-95 from SR 90/SW 8 Street to SR 5/US 1/S Dixie Highway:

The proposed improvements include repaving and restriping the shoulder pavement; upgrading guardrail; upgrading vehicular signs; replacing pavement markings and installing signage. Construction is expected to begin September 2023 and last about one year. The estimated construction cost for this project is \$809,948.

The meeting will consist of a formal presentation followed by an open discussion. Staff will be available to answer questions in the order they are received and as time permits. If your question is not responded to during the meeting, a response will be provided in writing afterwards.
