LANE CLOSURE INFORMATION

Work will be done in phases to reduce the effects of construction on the community. Travel lanes and sidewalks can be closed during the following hours on non-event days:

- SR 5/US 1/Biscayne Boulevard from NE 61 Street to NE 64 Street:
- 11:30 p.m. to 7:30 a.m., weekends and weekdays
- SR 5/US 1/Biscayne Boulevard from NE 64 Street to NE 6 Avenue:
- 9:30 a.m. to 3:30 p.m., weekends and weekdays
- 9 p.m. to 7 a.m., weekends and weekdays

Access to businesses and residences will be maintained. Lane closure information will be posted weekly on the department's website, www.southflroads.com.



WHAT TO EXPECT

Work will be done in phases to reduce the effects to the community. Temporary lane closures may affect traffic during non-peak hours and nonevent days. All detours will be established with clear signage. Access to adjacent properties will be maintained.
