FDOT COMPASS

FDOT is committed to ensuring that the state's infrastructure serves residents, businesses, and visitors to meet their needs now and in the future. Key areas include safety, resiliency, supply chain, technology, and workforce development. The following benefits are included in this project:

COMMUNITY

- Replacing sidewalks and the median concrete barrier

SAFETY

- Upgrading vehicular and pedestrian signals, signs, and pavement markings
- Upgrading curb ramps, traffic railings, and shoulder barriers
- Installing new detectable warning surfaces

RESILIENCY

- Replacing the concrete pavement
- Repaving and restriping to preserve the service life of the road

SUPPLY CHAIN

- Converting the inside through/left lane to a dedicated left-turn lane at NE 5 Street
- Converting the existing through lane to a through/left-turn lane at NE 5 Street

TECHNOLOGY

- Enhancing the traffic signals at all signalized intersections

WORKFORCE DEVELOPMENT

- This project creates opportunities for contractors, which results in positive economic benefits for the workers and the community

LANE CLOSURE INFORMATION

Travel lanes and sidewalks will be closed during non-peak hours on non-event days.

Non-peak hours are:

Single and double-lane closures along S.R. 866/Port Boulevard:

- 5 p.m. to 5 a.m., Tuesdays through Thursdays

Single and double-lane closures along S.R. 5/Biscayne Boulevard:

- 8 p.m. to 6 a.m., Sundays through Thursday
- 11 p.m. to 9 a.m., Fridays and Saturdays

Access to businesses and residences will be maintained. Lane closure information will be posted weekly on the department's website, www.southflroads.com.



WHAT TO EXPECT

Work will be done in phases to reduce the effects to the community. Temporary lane closures may affect traffic during non-peak hours and non-event days. All detours will be established with clear signage. Access to adjacent properties will be maintained.
