# State Road (SR) 25/US 27/Okeechobee Road Corridor Wide Construction Update

Below is a list of ongoing construction activities and lane closure information for each project segment.

# **ONGOING CONSTRUCTION ACTIVITIES**

Segment Two: From east of NW 107 Avenue to east of NW 116 Way

- Performing roadway widening and drainage installation work along Okeechobee Rd, NW 116 Way/Hialeah Gardens Blvd, NW S River Dr, NW 121 Way and Frontage Rd
- Installing the following:
  - Bridge Walls
    - Lighting conductors along NW 116 Way/Hialeah Gardens Blvd
    - New pump station on NW 121 Way
    - Service points along Frontage Rd
  - Concrete pavement, and light poles along Okeechobee Rd
- Pile driving operations and bridge construction at:
  - Hialeah Gardens Blvd just north of Frontage Road
  - Okeechobee Rd and NW 98 Ave
  - Okeechobee Rd and NW 114 St
  - Okeechobee Rd at the NW 116 Way intersection
  - NW 121 Way continuation of demolition

#### **General Lane Closures**

- A single lane closure along NW 116 Way from Frontage Rd to W 68 St, in both the northbound and southbound direction.
- A single lane closure along Okeechobee Rd from NW 92 Ave to NW 107 Ave, in both the northbound and southbound direction.

Closures will take place Monday through Saturday during the following hours:

- 9 p.m. to 5:30 a.m. on weekdays
- 11 p.m. to 7:30 a.m. on weekends

### Continuous Lane Closures/Traffic Shifts

- Travel lanes are reduced to two lanes in each direction along the NW 116 Way bridge between Okeechobee Road and NW South River Drive.
- Traffic lanes are reduced to two lanes in each direction along Okeechobee Road from east of NW 107 Avenue to NW 92 Avenue.
- Full closure of the NW 121 Way Bridge

## UPCOMING: TRAFFIC SHIFT AND CLOSURE OF SR 25/US 27/OKEECHOBEE ROAD BETWEEN NW 116 WAY AND NW 105 WAY

Starting on Saturday, April 6, 2024, lane closures will be implemented along SR 25/US 27/Okeechobee Road south/eastbound lanes between NW 116 Way and NW 105 Way. Lanes will reopen by 5 a.m. on Monday, April 8, 2024. These closures will allow the contractor to shift south/eastbound SR 25/US 27/Okeechobee Road to the north, creating a protective work zone adjacent to the Miami Canal. See closures below:

#### Daytime Closure

• 6 a.m. to 9 p.m. – Single lane closure along SR 25/US 27/Okeechobee Road south/eastbound lanes between NW 116 Way and NW 105 Way


Nighttime Closure

 9 p.m. to 5 a.m. – Full closure of SR 25/US 27/Okeechobee Road south/eastbound lanes between NW 116 Way and NW 105 Way

The following detours will be implemented during the full nighttime closure of SR 25/US 27/Okeechobee Road south/eastbound lanes.

- Motorists heading north on NW 116 Way wishing to access south/eastbound SR 25/US 27/Okeechobee Road will be detoured to make a right at NW South River Drive, continue to NW 105 Way, make a left at NW 105 Way, and make a right at SR 25/US 27/Okeechobee Road to continue heading southeast.
- Motorists heading south/eastbound on SR 25/US 27/Okeechobee Road wishing to continue, will be detoured to make a left at the NW 98 Avenue ramp, make a right at Frontage Road, make a left at NW 116 Way/Hialeah Gardens Blvd, make a left at NW South River Drive, continue to NW 105 Way, make a left at NW 105 Way, and make a right at SR 25/US 27/Okeechobee Road to continue heading southeast.
- Motorists heading south on Hialeah Gardens Blvd/NW 116 Way wishing to access south/eastbound SR 25/US 27/Okeechobee Road will be detoured to continue south at the intersection, make a left at NW South River Drive, continue to NW 105 Way, make a left at NW 105 Way, and make a right at SR 25/US 27/Okeechobee Road to continue heading southeast.

Please note that this schedule may change due to bad weather or other unforeseen conditions.
